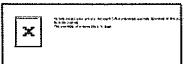

Dear Board of Supervisors,

I am writing to encourage approval of D22.17, which increases the primary property tax levy by \$0.03 and dedicates the increased revenues to building and maintaining affordable housing in Pima County.

The need is great, and the process to build housing is too slow. Increasing revenues available to provide both maintenance of existing housing stock and GAP funding to finance construction should help to alleviate the terrible shortage of housing especially for those living below the poverty line. The study done by EcoNorthwest clearly illustrates where the need for housing lies in the County.

My only concern is that the increased levy could be harmful to homeowners already living near the poverty line or on low fixed incomes. Perhaps the bill could be modified to account for this.
