# PASCUA YAQUI TRIBE

RESOLUTION NO. C06-159-25

## RESOLUTION OF THE PASCUA YAQUI TRIBE APPOINTING PABLO RIVERA TO SERVE ON THE PIMA COUNTY REGIONAL AFFORDABLE HOUSING COMMISSION.

**WHEREAS,** the Tribal Council has the power to adopt resolutions, rules and regulations to protect and promote the general welfare of the Pascua Yaqui people and to facilitate the conduct and operation of the tribal government (Constitution of the Pascua Yaqui Tribe, Article VI, Section 1 (o)); and

**WHEREAS,** on May 6, 2025, the Pima County Board of Supervisors ("Board") expanded the Pima County Regional Affordable Housing Commission ("Commission") to include one member appointed by the Pascua Yaqui Tribe; and

**WHEREAS,** the Commission is tasked with providing input and recommendations to the Board to shape public policy and steer funding for affordable housing in Pima County; and

**WHEREAS,** the Tribal Council has determined it is in the best interest of the Pascua Yaqui Tribe and its members for Deputy Housing Director, Pablo Rivera to serve on the Pima County Regional Affordable Housing Commission.

**NOW THEREFORE BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE PASCUA YAQUI TRIBE** that (1) it hereby appoints Deputy Housing Director Pablo Rivera to serve on the Pima County Regional Affordable Housing Commission; (2) the appointment shall take effect immediately and be contingent upon his continued employment with the Housing Department of the Pascua Yaqui Tribe; and (3) it authorizes the Chairman to provide communication and sign any documents required by Pima County to memorialize the appointment.

### CERTIFICATION

**THE FOREGOING RESOLUTION** was on **June 26, 2025**, duly adopted by a vote of **EIGHT** in favor, **ZERO** opposed, and **ZERO** abstained, by the Tribal Council of the Pascua Yaqui Tribe pursuant to the authority vested in it by Article III, Section 2 and Article VI, Section 1 (o) of the Constitution of the Pascua Yaqui Tribe adopted on January 26, 1988 and approved by the Secretary of the Interior on February 8, 1988, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
