First I was ashamed for the legislative approach to interview Dr. Cullen. I want to emphatically state my full support for her as PCHD Director.

I had the good fortune and pleasure to work with /Dr. Cullen to (correctly) navigate COVID in intercollegiate Athletics. As Director of Athletic Medicine for the University of Arizona, we spoke often. Dr. Cullen was a key member on our UArizona Athletic COVID Advisory team we met every other week.

I also serve on the Pac-12 Executive Committee for SAHWBI (Student-Athlete Health Wellness Initiative Board). We worked extensively on COVID issues within the Pac-12 and all of Power 5 programs nationally. Dr. Cullen was an amazing resource. We at UArizona were extremely fortunate to have Dr. Cullen as a partner in our work. The fact that Dr. Cullen is a practicing physician (had years of public health background at IHS) who was running Public Health for counties was invaluable. Dr. Cullen approached medical issues—with a public health lens—from the perspective of a practicing physician, one who is comfortable in the grey areas of medical issues where life and death can be in the balance. We at UArizona had the best, most reasonable and well thought-out relationship with our county health with Dr. Cullen and we were lightyears ahead of all other counties in the Pac-12 footprint. (as a note, we at UArizona did not cancel one athletic event due to COVID and student athletes—that is a testimony to Dr. Cullen's leadership and shared guidance,

Also, we had over 10 teams with 100% COVID vaccination, all others greater than 70%, again due in large part to Dr. Cullen's help). We also worked with the CDC—with the initial assistance of Dr. Cullen—to look at collegiate athletes and we together redefined time loss and time in isolation. That changed the narrative in the CDC and college sports and trickled down to the general population. That was a direct result of Dr. Cullen's leadership.

I often would share ideas, science, studies related to COVID with Dr. Cullen over the prime time of the pandemic. I feel Dr. Cullen made my job better, I feel I was able to navigate COVID better for UArizona and the Pac-12 (as well as division 1 sports) because Dr. Cullen was the PCHD Director.

Additionally, with the sad loss of a former student athlete last month, I was able to communicate with Dr. Cullen who unleashed the best of the PCHD to help prevent a potential health outbreak (it was not the case) while we were still working in early stages of post mortem with the County Medical Examiner.

I could go on for paragraphs of the importance that Dr. Cullen has brought to leading PCHD. I strongly encourage the reappointment of Dr. Cullen as PCHD Director, unequivocally.

I disagree 100% with the partisan, personal attacks on Dr. Cullen's record while in the subcommittee stage vetting for State Health Director. 
