My experience with Kristen Randall has been in a professional capacity when she assisted me with the process of eviction through the Green Valley Justice Court. I live in a rural area, and purchased a property that had trespassers on the property. I called and spoke with many of the personnel at the GVJC and was treated as if I should know the process and understand how to proceed without their guidance.

I was unable to fully understand what documents to fill out and the order of process. I live 5 hours away and not understanding this process was very difficult for me. I wanted to understand what my rights were and what kind of commitment with travel, time etc that I was looking at to make sure I planned accordingly. I was given the advice to "hire a lawyer" for the staff at the courts.

I was not in the financial place that I could just "hire a lawyer" and when I did call for law advice, was told by a lawyer that it was not necessary as I had trespassers and not renters.

Long story short, by the time that I was visiting the courts for the 3rd time, Kristen Randall walked by and offered some non biased, factual information which I found invaluable. I was not wanting to avoid the process, just understand the process.

After months and several more visits to the court, Kristen stands out as a beacon for the public with her calm demeanor and ability to listen, relay information with articulation and kindness. These are the characteristics that should be in charge of serving the public.

On another note, Kristen Randall has been spearheading the rescue and feeding operation of the animals that have been left behind during this crisis time at the border of Sasabe AZ. This is a lady with a huge heart and ability to recognize and address public emergency situations.

I fully endorse Kristen Randall in the position she is seeking for the Pima County Board of Supervisors.
