Title: Temporary Road Closure Resolution

Introduction/Background:

The reason for this resolution is that Perimeter Bicycling Association of America has requested the temporary closure of portions of Mission Road, Nogales Highway, Kolb Road, Yucca Via, and Silverbell Road for the El Tour de Tucson event on Saturday, November 18, 2017 from 5:00 A.M. to 5:00 P.M.

Discussion:

As a result of the request, Pima County Traffic Engineering recommends the temporary closure of portions of Mission Road, Nogales Highway, Kolb Road, Yucca Via, and Silverbell Road to enhance the safety of the El Tour de Tucson event by reducing the potential for vehicular conflicts.

Pima County Traffic Engineering recommends approval of this resolution to temporarily close portions of Mission Road from 400 feet south of Brown Drive (Pima County limits) to Drexel Road, Nogales Highway from Los Reales Road (Pima County limits) to Aerospace Parkway, Kolb Road from 1520 feet north of Via Rio Pico (Pima County limits) to 600 feet north of Valencia Road (Pima County limits), Yucca Via from Old Ina Road to Ina Road, and Silverbell Road from Abington Road (Pima County limits) to 460 feet south of Sweetwater Drive (Pima County limits) on Saturday, November 18, 2017 from 5:00 A.M. to 5:00 P.M.


