CONTRACT AMENDMENT

WHEREAS, Pima County, a body politic and corporate of the State of Arizona, hereinafter called COUNTY, and Jerrilyn (Jerri) Blackman, hereinafter called CONTRACTOR, have entered into a Contract dated July 10, 2012, pertaining to Pima Animal Care Center administrative hearing officer services; and

WHEREAS, COUNTY and CONTRACTOR desire to amend said Contract to extend the Contract for a one-year period from July 1, 2013 through June 30, 2014, revise Article II - Scope of Work and increase funding by \$4,500 from \$4,500 to \$9,000 for the period from July 1, 2012 through June 30, 2014.

NOW THEREFORE, it is agreed as follows:

I. Replace Article I – Term and Extension/Renewal, with the following:

“This Contract, as awarded by the Procurement Director, shall commence on of July 1, 2012 and shall terminate on June 30, 2014 unless sooner terminated or further extended pursuant to the provisions of this Contract. The parties may renew this Contract for up to three (3) additional one-year period(s) or any portion thereof. Any modification, or extension of the contract termination date, shall be by formal written amendment executed by the parties hereto. Amendments to the Contract must be approved by the Board of Supervisors or the Procurement Director, as required by the Pima County Procurement Code, before any work or deliveries under the Amendment commences.”

II. Replace Article II.A – Scope, with the following:

“The CONTRACTOR shall conduct administrative hearings to determine dangerous animals, pursuant to Tucson City Code Chapter 4.4-13 and Pima County Code 6.04.150; excessive noise

pursuant to Pima County Code Chapter 6.04.160; canine-wild animal hybrids pursuant to Pima County Code Chapter 6.05.010 – 6.05.060; impoundment time, notice and costs pursuant to Tucson City Code Chapter 4.4-99; and disposition of animals pursuant to Tucson City Code Chapter 4.4-12.”

III. Replace Article III.B – Payment, with the following:

“Total payment for this Contract shall not exceed \$9,000, of which not more than \$4,500 shall be expended for the period from 07/01/12 through 06/30/13 and no more than \$4,500 shall be expended for the period from 07/01/13 through 06/30/14.”

III. The effective date of this Amendment is July 1, 2013.
