*Purpose:

The County requests approval for a no-cost extension (NCE) through 12/31/2024 to utilize the remainder of the Safety and Justice Challenge (SJC) Focused Racial Equity Cohort (REC) grant funds. The total grant award was split between the County and community partner, the YWCA of Southern Arizona. On 1/18/2022, The Board of Supervisors accepted the County's portion of the two-year grant. The grant aims to advance racial and ethnic equity in the justice system, center lived experience, and emphasize the SJC Community Engagement Pillars of authenticity, accessibility and transparency, respect for diversity, and commitment to ongoing engagement.

Due to inter-departmental collaboration and capacity increases, the County has experienced cost savings. A no-cost extension will allow the County to continue to expend funds on existing pre-approved budget line items, such as supporting community engagement contracts and activities.

*Procurement Method:

The grant award amendment did not require PCAO's review or signature.

Safety and Justice Challenge (SJC) Focused Racial Equity Cohort

*Program Goals/Predicted Outcomes:

The partnership between Pima County and the YWCA of Southern Arizona aims to establish an infrastructure for equity by increasing data access and transparency, community and youth engagement, and community innovation and collaboration.

*Public Benefit:

Approving the no-cost extension will further enhance grant activities and directly impact those in our community who are utilizing programs.

*Metrics Available to Measure Performance:

The grantor requests reports as needed to ensure programmatic and fiscal adherence.

*Retroactive:

Yes, to July 1, 2024. The County received approval and the amendment from the grantor on August 15, 2024. If not approved, grant activities would cease and consequently, unused funds would be returned to the grantor.
