**Title:** Temporary Road Closure Resolution

**Introduction/Background:**

The reason for this resolution is that Events for Everyone, LLC has requested the temporary closure of portions of Kinney Road, Mile Wide Road, and McCain Loop for the Everyone Runs Veteran's Day Marathon, 1/4 Marathon and 5K Run and Walk event on Sunday, November 12, 2017 from 6:55 A.M. to 11:00 A.M.

**Discussion:**

As a result of the request and traffic control plan review, Pima County Traffic Engineering recommends the temporary closure of portions of Kinney Road, Mile Wide Road, and McCain Loop to enhance the safety of the Everyone Runs Veteran's Day Marathon, 1/4 Marathon and 5K Run and Walk event by reducing potential vehicular conflicts.

**Conclusion:**

Pima County Traffic Engineering recommends the temporary closure of portions of Kinney Road from Mile Wide Road to Hal Gras Road, Mile Wide Road from Sandario Road to Kinney Road and McCain Loop to enhance the safety of the Everyone Runs Veteran's Day Marathon, 1/4 Marathon and 5K Run and Walk event by reducing potential vehicle conflicts.

**WHEREAS**, the Pima County Board of Supervisors has determined that it will be necessary to permit the temporary closure of portions of Kinney Road from Mile Wide Road to Hal Gras Road, Mile Wide Road from Sandario Road to Kinney Road, and McCain Loop to support this event,

**THEREFORE, IT IS HEREBY RESOLVED** by the Board of Supervisors of Pima County, Arizona, that:

**SECTION 1.** Portions of Kinney Road from Mile Wide Road to Hal Gras Road, Mile Wide Road from Sandario Road to Kinney Road, and McCain Loop shall be temporarily closed to public traffic on Sunday, November 12, 2017 from 6:55 A.M. to 11:00 A.M.




