*Purpose:

Amendment of Award: Master Agreement No. MA-PO-19-183, Amendment No. 10. This Amendment extends the termination date to 03/31/2025 and increases the not-to-exceed contract amount by \$120,000.00 for a cumulative not-to-exceed contract amount of \$615,000.00. Administering Department: Human Resources.

*Procurement Method:

Pursuant to Pima County Procurement Code 11.24.010, Cooperative procurement authorized, on 06/27/2019, the Procurement Director approved an award of contract for an initial term of one (1) year in the annual award amount of \$60,000.00 with four (4) one-year renewal options.

On 08/27/2019, the Procurement Director approved Amendment No. 01, which replaced Exhibit A: Pricing with Exhibit A-1 Pricing, adding Employment Verification Bundled Package and Employment Verification Education Bundled Package.

On 10/10/2019, the Procurement Director approved Amendment No. 02, which increased the annual award amount by \$30,000.00 from \$60,000.00 to \$90,000.00 for a cumulative not-to-exceed contract amount of \$90,000.00. This increase was required for additional spending capacity for background checks and variable "pass-through" costs.

On 12/06/2019, the Procurement Director approved Amendment No. 03, which added an additional Background check package for No Employment + Education.

On 03/18/2020, the Procurement Director approved Amendment No. 04, which extended the termination date to 06/30/2021. No additional funds required. Three (3) renewal options remained.

Effective 07/01/2021, the Procurement Officer processed Amendment No. 05, which extended the termination date to 06/30/2022 and added a partial annual award amount of \$71,000.00 for a cumulative not-to-exceed contract amount of \$161,000.00. Two (2) renewal options remained.

On 05/12/2022, the Procurement Director approved Amendment No. 06, which increased the not-to-exceed contract amount by \$95,000.00 for a cumulative not-to-exceed contract amount of \$256,000.00. This increase was required to address the more frequent usage of the system as a result of an increase in recruitment needs.

Effective 07/01/2022, the Procurement Officer processed Amendment No. 07, which extended the termination date to 06/30/2023 and added a partial annual award amount of \$74,000.00 for a cumulative not-to-exceed contract amount of \$330,000.00. One (1) renewal option remained.

Effective 07/01/2023, the Procurement Officer processed Amendment No. 08, which extended the termination date to 06/30/2024, added the annual award amount of \$90,000.00 for a cumulative not-to-exceed contract amount of \$420,000.00, and added the Forced Labor of Ethnic Uyghurs language pursuant to A.R.S. § 35-394. No renewal options remained.

On 01/02/2024, the Procurement Director approved Amendment No. 09, which increased the not-to-exceed contract amount by \$75,000.00 for a cumulative not-to-exceed contract amount of \$495,000.00. This increase was required to address the more frequent usage of the system as a result of an increase in recruitment needs.

This extension is required to maintain employment screening services during the implementation of HR functionality in the new ERP system.
