Subject: Parking ordinance voting on 8/19

Dear Supervisor Miller,

I am concerned about the proposed ordinances Albany Avenue and Paseo Rancho Escondido. I am a resident/voter in District 1 and my son also attends Legacy Traditional School across from these roads. Currently, parents are utilizing these two roads to assist in picking up and dropping off of their children. I believe the new ordinance will cause more traffic and congestion.

I am requesting that you VOTE TO TABLE the request so that we may discuss alternative options. Parents are mainly parking on the Paseo Rancho Escondido, which is a wide road with no resident driveways. The cars are there less than 15 minutes at a time. The total time cars/traffic is present is approximately 30 minutes. After this, traffic clears. Alternatives to a no parking ordinance would be 15 minute parking, parking on only one side of the road, and no parking 10 feet or so from the intersection for visibility. This will alleviate the safety concerns that the neighborhood has and keep traffic out of the rest of the area.

Passing a blanket "no parking" ordinance will force parents to park in the adjoining neighborhoods and businesses, and will also cause extreme stationary traffic on the busy street of Cortaro. This will cause safety concerns for emergency vehicle access along this road, to businesses nearby, and into the school parking lot. Before parents starting utilizing these roads during pick up, the time my car (one parent out of 1100 kids) was in traffic on Cortaro was 1.5-2 hours.

Dear Ally Miller, It has been brought to my attention that Rancho Escondido Home Owners Association has approached to the county asking for parking restrictions in there community. I have one child in school at Legacy Traditional School, which is an excellent school and they are providing exceptional education to my child and others that have their child enrolled there. However there are no buses to pick up or drop off our children, so it is our responsibility to get them to school and back. They have a pickup and drop off system but with so many families having their children enrolled at the school creates chaos while dropping off and picking up your children. The newly expanded Cortaro Road does help to some extent but traffic still backs up. We have always parked on Paseo Del Rancho Escondido or Albany Avenue and just walked up to the school to drop off or pickup to avoid the long lines of traffic. I now see that the community has put up no parking signs on these streets. So now the parents that were parking there to

drop off or pickup their children now have to find an alternate place to park or sit in the long lines of traffic (causing a hazard) to pickup their children. I am being told that the Pima County Board of Supervisors will be voting on these ordinances very soon. I would like to point out that I do see some people that are violating normal parking regulations ie: parking too close to an intersection, and these people should be cited because it is not allowed to park that close to an intersection anywhere in the state. But restricting all parking for the entire community is going to cause some severe backlash at the expense of our children. With this restriction in place I have now seen parents that are dropping their children off at the curbside on Cortaro at the cross walk. This is very dangerous and is going to cause someone to get hurt. I understand where the community is coming from but I also don't want to see children's lives being endangered just so people don't park on one street. My suggestion is to either make it no parking on one side of the street or limit the amount of time to 15 minute parking between 0730 and 0830 hours and 1430 to 1530 hours all other times no parking. This would allow parents to park here but would not allow them to be parked there all day or for longer than 15 minutes at a time. Please think about this option and think about the safety of our children. Thank you for your time. Jody Rammell
