Approximately six million illegal aliens have entered our country since the Biden Administration has taken office. We've received illegal aliens from 162 countries. They're processed as a Notice to Appear with a Warrant for Arrest (NTA/WA) and sent to a detention facility to await their asylum hearing. So, the people here, in our city, receiving benefits that you gave them with our tax dollars are illegal aliens.

The pictures you see behind me are just a mere fraction of the American citizens killed by illegal aliens every year. Matt Heinz wants you to believe that Pima County and Katie Hobbs have the border crisis and invasion under control. That this is a humanitarian effort. Showing up at an NGO's welcome center with Hobbs, media and having the red carpet rolled out for you is myopic and denying the reality of what's truly happening at our southern border. Let's be honest it's a political photo op! I suggest you go spend some time down at the border with the hard-working men and woman of CBP and DHS and find out what's really going on.
