Title: Pima County Workforce Investment Board ("WIB") Recommendation for One (1) New WIB Member to be Appointed to the WIB

# Introduction/Background:

The Workforce Innovation and Opportunity Act ("WIOA") Section 107(b)(2) requires the following local workforce development board composition criteria for the Pima County Workforce Investment Board ("WIB"):

Section A. A majority of the board must be Business representatives and must have optimum policymaking or hiring authority as documented by job title (owner, chief executive officer, or chief operating officer) or written documentation from the company.

WIB Requests for Appointment applications are vetted by the WIB Board Development and Executive Committees.

## **Discussion:**

The Pima County Workforce Investment Board ("WIB") recommends to the Pima County Board of Supervisors, that one (1) new Pima County WIB member be appointed to the Pima County WIB.

Jennifer Preston, Lead Human Resources Manager, Caterpillar, is applying to represent the Business category and the Pima County WIB's Infrastructure in-demand industry sector.

If Jennifer Preston is approved and appointed to the Pima County WIB, Jennifer will replace Dorothy "Dot" Kret in the Business category and Jennifer's Term will be from May 18, 2021 to September 30, 2024.

This new appointment will assist the Pima County WIB with continuing to meet and maintain the following board composition requirement under the Workforce Innovation and Opportunity Act ("WIOA"):
