Re: **Response to the Board of Supervisors' February 1, 2022 Request for Breakdown of Vaccinated Pima County Population**

During the February 1, 2022 meeting Supervisor Scott requested an age breakdown of the vaccinated pediatric population.

Despite the relatively recent approval of COVID-19 vaccine for pediatric use, Pima County has made great progress in delivering vaccination to these age groups. Reliable updated data is only available by age group for first doses and can be found as an attachment to this document. At this time 48 percent (28,411) of the 5 to 9 population has received a first dose of this vaccine. This increases to 65 percent (62,299) for the 10 to 14, and 73 percent (69,243) for 15 to 19-year age group.

This degree of penetration in pediatric age groups over such a brief period of time is quite impressive, and affirms our strategy to prioritize school age vaccination.

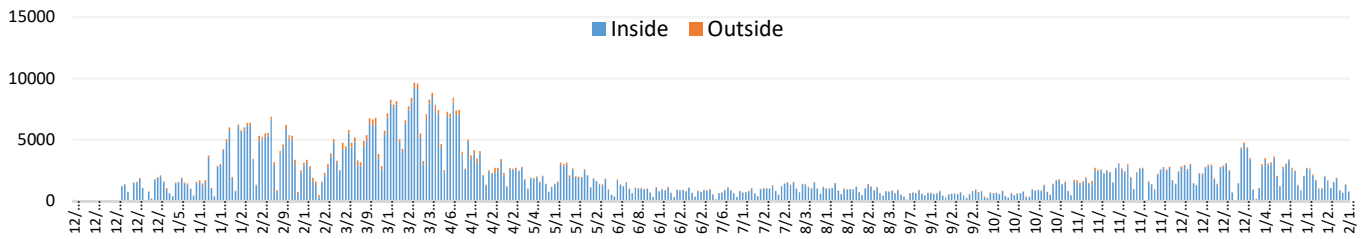
Pima County COVID-19 Vaccination Report

February 2, 2022

Total doses administered to Pima County residents: 1,715,126*

As of February 1, 2022, a total of 894,269 (85.60%) Pima County residents have received their first dose of a COVID-19 vaccine. A total of 849,897 residents were vaccinated by a local provider in Pima County ("inside") and 44,372 residents were vaccinated by a provider outside of the county ("outside"). Note, dates that don't appear in graphs had zero vaccinations. *Total number of vaccine doses administered to Pima County residents by all vaccine providers.

[†] Because of difficulty linking doses, overestimates of first doses and underestimates of subsequent doses can occur. Therefore, CDC methodology was used to cap first time vaccine doses at 95%.
