Re: **Disposition of Surplus County Vehicles**

At the April 19, 2022 Board of Supervisors meeting, Supervisor Grijalva inquired about the process for surplus vehicle donations. Pima County vehicles that have met their useful lives are determined to be surplus and scheduled for auction through our contracted vendor. The Fleet Services department is responsible for monitoring useful life based on life-to-date maintenance costs, life-to-date mileage and vehicle age.

Requests for surplus vehicle donations are infrequent and random. The requesting party is typically a non-profit organization that has reached out directly to County Administration or a County Supervisor. Table 1 lists surplus vehicle donations from 2012 to 2022.

Currently, Fleet Services contracts with Sierra Auction. Pima County vehicles are auctioned once a month based on availability. Cash proceeds from auctions are recorded as revenue in the Fleet Services Internal Services Fund. County departments that own specialty vehicles will receive the revenue directly.

Auction sales have generated the following Fleet Services revenues over the past three years:
FY 2019 - \$371,366; FY2020 - \$623,840; FY2021 - \$702,532.
