2022 Primary Election - Voter Concerns

As discussed, attached are email and telephone messages received by the District 4 office from concerned voters throughout Pima County regarding the August 2, 2022 Primary Election.

To reiterate the summary I presented during yesterday's Board of Supervisors meeting:

- Clarification, once and for all, on ballpoint pens vs. Sharpie pens vs. Flair felt-tip markers and their usage on ballots.
- Why did sample ballots (noting some Election Day voters did not receive them) not mirror actual voter ballots?
- Delays and long waits at some Voting Centers due to printers not working, running out of ballots, and having no provisional ballot envelopes.
- Explanation of the issuance of Federal-only ballots and Provisional ballots.
- Woefully lacking poll-worker training with inaccurate and incomplete information presented by the Elections Dept. trainer.
- Were all of the Vote Centers fully staffed with a proper 50/50 poll worker balance by party affiliation? A review of the Election Director's report of July 14, 2022 shows that of the 129 Vote Centers, 45 had unbalanced staffing, six had no Republican poll workers, and two had no Democrat poll workers.
- The County Recorder would not allow any observers during Early Voting, citing an unspecified policy of "COVID pandemic measures". Why?
- Definition of confusing terminology such as "poll-workers" vs. "poll-watchers" vs. "poll-observers" and their respective functions and responsibilities.

I look forward to the discussion of the After Action Report from our Elections Director and the Pima County Recorder during the October 4, 2022 Board of Supervisors meeting.



We were told that we are still using the felt markers, and that they bleed through but will not alter the count. We were told that an attempt was made to order ball point pens but due to supply chain issues they couldn't get enough. This morning I reported for work as JOP (Republican). I was only able to identify one other JOP, also new. Neither of us was asked to help in the night before setup, which makes me wonder if any Republicans were there. I was asking where to sit and the gentleman (clearly a regular) sitting at the first table said it didn't matter. I mentioned that there was supposed to be a person from each party at each check in and he again stated it didn't matter, which makes me wonder if they

have been following that rule. I then found ball point pens in the supply box and put one at each voting cubby. Another worker named Luis went around and collected them all and replaced them with felt markers. We had words over which pens to use and I informed him of what we were told in training. I said ok and asked if voters could use their own pens, and she replied yes. At no time did I argue with Marsha or go against her instructions. Marsha chose to call a person named Yvonda Sullivan who told me I needed to go home for arguing with Marsha. She transferred the call to Evelyn Bustamonte who told me that I may not argue with the Inspector, to which I agreed. The call ended, I went back inside and shortly before the polls open a man named Thomas Guillen whose badge said 'intermittent' arrived, spoke to Marsha, called me outside,

Mr Christy, I was a credentialed Poll observer for the Pima Republican Party at Desert Sky Middle School (Rita Ranch). On election day, we had 452 walk in ballots, 262 dropped off early ballots. We were in the lobby of the gym, which was way too small for 11 voting booths, poll workers and voting public. The air conditioning was inadequate in that small space and, and there were times voters had to stand out in the heat/potential monsoon weather. We had only 2 ipads to check people in (should have had 5) and 1 printer (should have had a backup or extra printed ballots). Since they reduced our polling locations, and this location did 100 voters in 2020, you'd Comments:

ipads had to be shared between the 2 teams at the check-in table and the "Special Situation" desk for the 50 people who were either showing they had been mailed an early ballot or whose address didn't match. The 1 printer did break down, at the worst time, and we had several voters leave. Those who were on the early mailing list were asked if they could go get their ballot at home and bring it back in, as their vote would get counted sooner. We had a Democrat marshall who kept putting felt tip pens in the booths, even after someone put ballpoints in. I reported all this through the az.protectthevote website, but I wanted you to be aware. I can give you more detail if needed, plus my observations at the duplication room.

Following is a **compilation** of Informal comments from various Pima County 2022 Primary Voters. This information is from an Informal request to members of United Republicans for Arizona reported as of today. IF any further information is received it will be provided.

MOCK ELECTION

The Mock Election did not simulate a real election. So many problems it was worthless as a "real" trial. Referred to Recorder's office when no Inspector or official at Mock Election could answer questions. Drove to Recorder's office, she was too busy. Employees could not answer questions. Referred to leaving message and someone would return call or to send an email. Appears Recorder's employees need more education on answering questions OR the Inspectors working at various elections need more training.

EARLY VOTING July 2022 various locations

Not enough locations near Green Valley and South. Must drive too far north.

Complete system failed for about 10 minutes. Then all came up and appeared to work. Overheard conversation by workers indicating the system went down frequently. Voters stand around and wait Poll Workers wearing masks indicated Recorder, Gabriella told them to wear masks. When asked if they were just recommended to wear a mask. They said NO she told us to wear a mask. Updated information on mandates/masks etc should be provided to Recorder.

Poll Worker handing out early ballot mentioned ballot is double sided but voter did not have to vote on the second side. She repeated her information when asked again. Poll workers do not give political advice, more training needed.

Confusion by poll workers on handing out ballot to voter after check-in.

TRAINING FOR POLL WORKERS AT Casino location

Training provider was confusing and not coordinated with training materials. Pima County needs to coordinate the presentation with the training materials for poll workers to follow along with the information. Once training materials are updated before the 2024 General Election, Pima County should have employees who are NOT familiar with the equipment or training information given two hours to set up, prepare paperwork, as if they are preparing for voters to arrive. Then asked to provide feedback on the problems. Problems, concerns should be corrected BEFORE 2024 General Election.

EARLY SETUP for PRIMARY VOTING DAY 8/2/22

Confusion on paperwork provided by Pima County on Layout for room and missing documentation. Missing supplies of Emergency Ballots and Provisional Ballot Envelopes. Reported by Inspector to contact at 6PM Monday 8/1/22 Received 8./2 @ 10AM. Inefficient, caused problems at polls. Information for locks on cases caused confusion, took too long to finish

Closing doors to secure Voting room @ VC106 was problem for custodian. Fixed and secured within 1/2 hour. Contract/arrangements for all voting locations should require security ASAP following closing of poll location.

Based on size of box compared to 600 blanks for BOD printer there were about 1800 emergency ballots (3 boxes @ 600 each) NOT 3600 emergency ballots. Returned emergency ballots in unopened boxes.

Unofficial Return Instructions had contrary information: SEAL ENVELOPE then DO NOT SEAL ENVELOPE on the same sheet of paperwork

Voting space custodian could not lock doors. Equipment remaining was the BODprinter, voting booths in containers, locked steel cage on wheels with e-poll books, Easy Vote machine, ballot paper, other Much confusion on close out paperwork provided by Pima County

Taking too long to complete paperwork and deliver

Some poll workers did not leave voting poll until 8:45, 9:30, 10:45 much confusion and problems providing ballots for delivery and pickup

Wednesday 8/3 following 8/2/22 voting day. Observed voting equipment remaining at Canoa Ranch in unlocked/open space. Pima County should have a contract ensuring secured space for equipment. Not enough E-Poll Books.

Needed extension cords for equipment, not provided. Had to adjust layout of tables to accommodate plugs in the room.

No training provided for Observers in Elections Duplicate, processing or tabulation.

Unknown if Recorder's signature verification had observers at any or all times.

Unknown if Express Vote machine in Duplicate processing area provides an official "count" at beginning and ending of each Batch.

Dear Pima County Supervisor of District 1 and 4;

A few notes from my day of working at the poll on primary election day. I volunteered to work at the voting poll for my first time. I worked at the poling center located at Udall Park. My eyes were opened to the operation of polling places and the support (or lack) of the elections department during my 5 a.m. – 8 p.m. shift. I must report to you, County Supervisor of these areas most like effect and for my voting neighbors, situations that occurred that effect ones right to vote.

Doors open at 6 a.m., we are ready for the voting public. **Missing** from the elections department supplies for this voting center were provincial envelopes for the ballots. We had none. It took <u>2 hours</u> for a staff member to deliver the envelopes. Voters were not happy, as a matter fact they were very angry. Do we not understand when these voters who say "the fix is in" and who are disgusted with the system saying they won't come out to vote again because of situations like this? Angry folks, very angry. Ah, but it happened again. We ran out of provincial envelopes around 2:30 p.m. More angry voters. We were told to take voters phone numbers to call them to come back when envelopes arrived. REALLY? Voters left; did they go somewhere else? They certainly did not come back. It took close to an hour for more envelops to be delivered. WHY?

I worked the Special Situations table. We had 100 special situations, 95% of the situations were voters not turning in early or mail-in ballots. These voters said over and over again they don't want nor requested an early or mail-in ballot. These voters were not happy. I could only suggest they go to the Pima County/voter registration website and update their information.

Around 1 p.m. workers from the Kirk-Bear Canyon Library voting center joined the Udall Park voting center. The Kirk-Bear Canyon voting center CLOSED. This location ran out of ballot paper. I'm sure by now you have heard of this closure.

When you hear candidates saying the elections/voting process is scandalous, you, yourself need to work a polling place. Voters don't trust the process. Several voters angrily expressed their opinion and displeasure of the process. It is the voter who doesn't trust the system, it is the voters!

I will work the poll again. I fear what could happen in November.

We received our ballots in the mail.

A few years ago, the recorders office called because our ballots were returned. As it turned out, we were in the mountains with mail on forward. I was informed that ballots were not allowed to be forwarded so it was sent back to the county. Your staff was kind enough to call us to see what happened and it was resent to our home after the forwarding was removed.

This election, there was not a DO NOT FORWARD notice on the envelope. The new boxes to return if someone does reside at the address seems to be an invitation to voter fraud. It seems like this was done intentionally as it will result in many fraudulent votes being cast.

I am a REALTOR so have access to the Multiple Listing Service of Southern Arizona. When doing research in early June, there were over 13,000 owner occupied properties sold since the last election. When a home sells, the county requires an Affidavit of Value. In that form, the Seller fills in their future address and the property is transferred to the new owner using this form. That is 26,000 households when you consider buyers and sellers. If half of those were married or partner owned properties, that totals 39,000 potential faulty votes in only 18 months noted in the Southern Arizona Multiple Listing Service. Many properties are sold outside the system so there could be a much larger number.

The County recorders should have been following up with all buyers and sellers involved with a sale. An Affidavit of Value is completed with each sale so the county knows who all these parties are so the voter rolls should be constantly updated. Same thing for Death Certificates. Since the county tracks deaths within the county, every deceased person should be removed from the voter rolls immediately upon notification.

Please advise on when the mail in ballots had the request for address correction added.
