Dear Board of Supervisor and other elected officials:

I am writing to inform you that I do not believe that this past mid-term election should be certified. The chaos and apparently deliberate manipulation of the vote through malfunctioning machines, the use of unlawful practices led to disenfranchisements of voters at the poll such as turning people away, co-mingling of counted and uncounted ballots, and mismatches between ballots and voters. The Chain of Custody of ballots has been broken. The election is tainted and cannot be made right unless a new election is conducted without the interference of machines and processes constructed around opaque black box machines.

This election reminds me of the 2020 election that has been adequately proven to be full of fraud by various audits and analysis. Having the same concerns as in 2020, I believe this election should be corrected now. I respectfully urge you to NOT CERTIFY this election and then take the measures and re-do the election with election integrity measures in place.

I arrived at the polling place in my neighborhood at 550a. There was about 40 people in line ahead of me waiting for the doors to open. It took me nearly 2 hours to vote! The reason it took so long is because the tabulators were not working properly. Within the first 30 minutes one machine was completely down and the other machine would not accept the ballots from a number of people, me included. I was told to stand to the side. I was left there for 20 minutes along with approximately 15 other people who had the same problem. No one was getting back to us or offering us any suggestions on what to do. So, I decided to get in line and try again. I tried on 3 separate occasions and fed by ballot to the tabulator 4-5 times on each try. Again, the poll workers just told me to stand aside. It had been 90 minutes and we were getting nowhere. I finally asked what my other options were and I was told to go somewhere else to vote or spoil my ballot and try again. I spoiled my ballot and tried again. It took the new ballot. I watched a number of frustrated people give up and leave. Voting was a nightmare! This process is corrupt!

After the 2020 election you would think Arizona would never allow themselves to be so embarrassed again. Yet, here we are again!

Another huge concern I have is why is Katie Hobbs overseeing the election count of her opponent? Absolutely incredible that this has been allowed! She needs to recuse herself!

Do not certify this election and instead get some measure in place that will restore election integrity and let's do this the right way!

We are raising our voice in dissatisfaction about the Arizona 2022 Midterm election and the chaos and apparently deliberate manipulation of the vote through malfunctioning machines, use of unlawful practices that led to disenfranchisement of voters at the poll such as turning people away, co-mingling of counted and uncounted ballots, and mismatches between ballots and voters. The Chain of custody of ballots has been broken. The election is tainted and cannot be made right unless a new election is conducted without the interference of machines and processes constructed around opaque black box machines to which none can provide oversight because we cannot "see" codes run at all times.

It is very hard to believe that such a high percentage of voting machines simply would not function correctly if the election was run in a proper manner. Personally, it took me an hour to have my vote processed. There was no line, but with the scanners malfunctioning, I was subject to voting three separate times just to have my vote counted. If there was no ill intent intended, then those in charge of the voting process forgot how to process votes since the primary.

Twenty to thirty percent of the machines could not process votes in the general election. The machines did not have an issue in the primary election. The general election was much more important than the primary. Seems reasonable to believe that one or more deliberate acts took place to cause such a mishap on the general election voting day. Also, it seems unethical that the Secretary of State who was in charge of certifying the election machines did not recuse herself and was able to declare herself the winner. Too many fishy things just happened on general election day that simply did not take place in the primary election. For the primary election day, voting centers did not have sufficient paper to process votes. This meant a different tactic was required for the general election.

This smacks of the 2020 election that has been adequately proven to be full of fraud by various audits and analysis. This must be corrected now. We respectfully urge and demand that you **DO NOT CERTIFY** this election and then take measures to redo the election with election integrity measures in place.
