*Title:

Renaming the Mockingbird Trail the Max Shemwell Trail

*Introduction/Background:

Max Shemwell was a tireless supporter of trails in Pima County. He was a member of Pima Trails Association and a long time committed trail volunteer with Sonoran Desert Mountain Bicyclists, Arizona Trail Association, Pima Trails Association and Pima County NRPR trails program. Max Shemwell assisted leading other volunteers on trail construction and maintenance projects and was instrumental in building trails in Arthur Pack Park and Tucson Mountain Park. After Max helped build the trails, he worked tirelessly to help maintain them and was passionate in advocating for public access to trails for all non-motorized users and for protecting open spaces.

*Discussion:

In following NRPR's Standard Operating Procedures for the naming of a park facility, NRPR received letters of support from the Shemwell family, County Line Riders of Catalina, Inc., Pima Trails Association, Sonoran Desert Mountain Bicyclists and trail advocates. This naming request was brought before the Pima County Natural Resources, Parks and Recreation Advisory Commission at its December 10, 2021 meeting and was unanimously approved by the commission.

*Conclusion:

After reviewing the letters of support submitted by the Shemwell family and various organizations and individuals who partner with PCNRPR Trails Program, Pima County Natural Resources, Parks and Recreation Advisory Commission voted unanimously to rename Mockingbird Trail in Tucson Mountain Park to Max Shemwell Trail.


CLRC suggested to Steve Anderson, that we should name a trail after Max because of his dedication to trails.
