The Dangers of Masks

we refer here to another looming concern and this is the potential danger of the chlorine, polyester, and microplastic components of the face masks (surgical principally but any of the mass-produced masks) that have become part of our daily lives due to the Covid-19 pandemic. We hope those with persuasive power in the government will listen to this plea. We hope that the necessary decisions will be made to reduce the risk to our populations.

Emergent reports, albeit nascent and anecdotal but nevertheless vitally important (and will be clarified and defined in time) regarding the manufacture of masks, where, "many of them (face masks) are made of polyester, so you have a microplastic problem...many of the face masks would contain polyester with chlorine compounds...if I have the mask in front of my face, then of course I inhale the microplastic directly and these substances are much more toxic than if you swallow them, as they get directly into the nervous system."

There are also reports of toxic mould, fungi, and bacteria that can pose a significant threat to the immune system by potentially weakening it. Of particular concern to us is the recent report of breathing in synthetic fibers in the face masks. This is of serious concern. "Loose particulate was seen on each type of mask. Also, tight and loose fibers were seen on each type of mask. If every foreign particle and every fiber in every facemask is always secure and not detachable by airflow, then there should be no risk of inhalation of such particles and fibers. However, if even a small portion of mask fibers is detachable by inspiratory airflow, or it there is debris in mask manufacture or packaging or handling, then there is the possibility of not only entry of foreign material to the airways, but also entry to deep lung tissue, and potential pathological consequences of foreign bodies in the lungs."

Reports are that "Graphene is a strong, very thin material that is used in fabrication, but it can be harmful to lungs when inhaled and can cause long-term health problems." We argue that there is a risk of potential 'future' inflammatory/fibrotic lung diseases because we are inhaling these materials in the masks now for over one year with more duration to come and no end in sight. These substances might also be highly carcinogenic. Not just for us as adults but we must be very concerned about the risks especially to our children since they depend on us as mentors and guides for their decision-making. It is our children that we are very concerned for.

These blue surgical masks pervade our lives. "Health Canada has issued a warning about blue and gray disposable face masks, which contain an asbestos-like substance associated with "early pulmonary toxicity."

The warning is specific to potentially toxic masks distributed within schools and daycares across Quebec. <u>Health Canada</u> (and full praise to them)...."discovered during a preliminary risk assessment that the masks contain microscopic graphene particles that, when inhaled, could cause severe lung damage."

Reports are that "for a while now, some daycare educators had expressed suspicion about the masks, which were causing children to feel as though they were swallowing cat hair while wearing them. We now know that instead of cat hair, children were inhaling the equivalent of asbestos all day long." It appears to be a substance known as graphene. What is indeed alarming is that "the SNN200642 masks that were being used all across Canada in school classrooms had never been tested for safety or effectiveness." This is indeed a catastrophic failure by the regulators as these surgical face masks are linked to early pulmonary toxicity.

What is indeed frightening is that all of these blue and similar surgical face masks cause <u>plastic fiber inhalation</u> and the outcomes could be devastating, especially to our children. These plastics will degrade very slowly over time and as such, in the lungs it may remain and just build up to dangerous levels. We do not even know what is an 'acceptable' level, for there should be none, zero! There is debate that the immune system can attack such foreign objects, thus driving prolonged inflammation which may lead to diseases such as cancer. And reused masks which pervade our daily lives, and based on our personal experiences, do produce more loosened fibers. Dr. Richard Urso showed us just how dangerous these are by putting them under a microscope, revealing the melt-blown polypropylene plastic. Some masks even contain <u>fiberglass</u> and this is very dangerous as we know to inhale. We as parents make these decisions, we have to step back and question many of these decisions we are making that seem suboptimal. If it does not seem right, then you have to push back and question and demand the science, demand the data from these seemingly untethered experts.

We caution you on the safety of these face masks especially since the science also has revealed the ineffectiveness of <u>mask mandates</u> and the masks themselves, as <u>currently used</u>. We are parents and citizens alike, and you and we only seek to inform, share, prognosticate. You must be informed fully for informed decision-making. We also cannot discount the possible harms on our immune systems and general health from such constant and prolonged use of masks, given that we have never done this before.

We are in uncharted territory and especially so with the possible implications for our children. Many countries introduced the requirement to wear masks in public spaces for containing SARS-CoV-2 making it commonplace in 2020. Up until now, there has been no comprehensive investigation as to the adverse health effects masks can cause. The aim was to find, test, evaluate and compile scientifically proven related side effects of wearing masks. For a quantitative evaluation, 44 mostly experimental studies were referenced, and for a substantive evaluation, 65 publications were found. The literature revealed relevant adverse effects of masks in numerous disciplines. In this paper, we refer to the psychological and physical deterioration as well as multiple symptoms described because of their consistent, recurrent and uniform presentation from different disciplines as a Mask-Induced Exhaustion Syndrome (MIES). The outbreak of the COVID-19 pandemic is causing a shortage of personal protective equipment (PPE) across the world. As a public health response to control the pandemic, wearing homemade face coverings has been proven as a resort to protect both the wearer and others from droplets and aerosols transmission. Although aerosols and droplets can be removed through these non-medical materials with a series of filtration mechanisms, their filtration performances have not been evaluated in detail. Moreover, many factors, such as the fabric properties and the method of usage, also affect filtration performance. In this study, the size-dependent filtration performances of non-medical materials as candidates for face coverings were evaluated comprehensively. The flow resistance across these filter materials, an indicator of breathability, was also examined. The effect of materials properties, washing and drying cycles, and triboelectric effect on particle filtration was also studied. Results showed that the filtration efficiency varied considerably from 5–50% among fabrics materials due to the material properties, such as density and microscopic structure of the materials.



University of Oxford Professor Jim Naismith recently spoke on the subject of masks and admitted, using data, that masks are pointless.

Naismith used the data that was collected from England and Scotland to prove the importance of masks. Back in July, England decided to do away with their mask mandate while Scotland continued to enforce the mandate. But now, after months of research, the data shows that the mask "has made no meaningful difference" when it comes to infection rates.

Although Scotland believed it would help stop the spread of COVID-19 to keep the mask mandate, the graph, which is shown above, proves that their infection rates were similar and in some cases higher than England.

Writing about the findings, Naismith, who is also the Director of the Rosalind Franklin Institute, noted, "The ONS survey results on prevalence shows that the Scottish and English approach to masking, although formally different since July, has made no meaningful difference to Delta." The Professor added, "In both countries very high levels of prevalence have continued for months. Thus the new changes announced are unlikely to have much of an impact if Omicron does indeed spread rapidly."

The findings presented by Naismith are also shared with the UK government SAGE adviser Dr. Colin Axon, who classified masks to be nothing more than "comfort blankets".

"The small sizes are not easily understood but an imperfect analogy would be to imagine marbles fired at builders' scaffolding, some might hit a pole and rebound, but obviously most will fly through."

Cloth masks are of little use against COVID-19, according to a recently published analysis.

A trio of researchers pored over the studies often cited by the officials and found they were poorly designed and offered scant evidence supporting mask usage.

Many of the studies are observational, opening them up to confounding variables, the researchers said in their analysis, which was published on Nov. 8 by the Cato Institute.

Of 16 randomized controlled trials comparing mask effectiveness to controls with no masks, 14 failed to find a statistically significant benefit, the researchers said. And of 16 quantitative meta-analyses, half showed weak evidence of mask effectiveness while the others were "were equivocal or critical as to whether evidence supports a public recommendation of masks," they added.

"The biggest takeaway is that more than 100 years of attempts to prove that masks are beneficial has produced a large volume of mostly low-quality evidence that has generally failed to demonstrate their value in most settings," Dr. Jonathan Darrow, an assistant professor of medicine at Harvard Medical School, told The Epoch Times in an email.

Due to the COVID-19 pandemic, policymakers cannot wait for higher-quality evidence to support masking, but from an ethical standpoint, they should "refrain from portraying the evidence as stronger than it actually is," the researchers concluded.

Dear Board Members, I'm writing to ask that the Pima County Board of Supervisors adopt the county-wide mask mandate for indoor public spaces as outlined in Resolution 2021-87.

It is proven that masking indoors decreases COVID-19 transmission rates [1]. It is, at most, an inconvenience that the community can quickly implement to keep businesses and schools humming along. There is no chance of vaccinating our way out of this variant.

Teachers and parents in Pima County schools with mask-optional policies have experienced unprecedented stress and anxiety. We have spent the past twenty weeks dealing with exposure quarantines and classroom closures. A county-wide mask mandate would provide some bare minimum mitigation in some Pima County schools.

The correlation between school districts with mask-optional policies and school districts with employee and substitute shortages shows a solid cause-and-effect relationship. Superintendents of mask-optional school districts have previously disclosed that they do not want help from the county, and clearly, they need help retaining employees and to keep children safe.

The implication of not following public health policy of multi-layer mitigation strategies has placed the burden on already-taxed parents and teachers stressed to the max. Parents of children with medically fragile children cannot be guaranteed that schools can keep their children safe. Ultimately, parents have no option but to withdraw their children from public school and begin homeschooling.

With the first case of Omicron detected on November 27th in the UK, today, the UK reported 90,000 cases. Pima County is still experiencing high community transmission with Delta, and the Omicron variant was just identified in Pima County this week. The concern is that the transmission rate of Omicron can easily overwhelm the hospital system. With Omicron R naught value estimated to be 3-4 times higher than Delta, we must be proactive in dampening the spread.

Omicron. However, monoclonal antibodies and the Regeneron antibody cocktail are ineffective against the Omicron variant, and the Sotrovimab monoclonal antibody is in short supply.

I am so relieved to see a county-wide indoor mask mandate back on the agenda for your upcoming meeting, and I urge you all to vote "yes" on the measure. For those of you who voted no on measures like this in the past, please understand that the situation with SARS-CoV-2, its variants, the vaccine's effectiveness, and the evidence we have supporting masks has evolved since then. There have been at least 18 new well-designed studies in the last year that prove wearing a mask indoors significantly decreases the transmission of SARS-CoV-2 with almost no ill effects to the wearer. One study just published on December 7th showed that "face masks significantly reduced the risk of SARS-CoV-2 infection compared to social distancing. We found a very low risk of infection when everyone wears a face mask, even if it doesn't fit perfectly on the face". The key here is that a vast majority need to be wearing a mask. The only way to accomplish that is with a mask mandate.

The Delta variant is still highly active, and now the Omicron variant is rapidly on the rise. My husband is a hospitalist in Tucson and can attest to the trend of increasing numbers of hospitalized patients with COVID-19, increasing numbers of ICU patients with COVID-19, and the decreasing availability of ventilators, ECMO machines, and services for non-COVID patients. This new surge is already severe and exhausting, and as we head into the holiday season full of gatherings and shopping in public and travel, we will surely see another huge spike in this pandemic. We have an opportunity to improve our county's mitigation efforts now, and lessen the severity of what is to come.

Thankfully, universal masking is a simple, effective, safe, inexpensive, and widely accepted mitigation method. An indoor mask mandate is a commonsense strategy that hundreds of cities and states are already doing, and the people originally opposed when a mandate goes into effect seem to easily adapt. Please don't allow a small minority of misled citizens who are opposed to a simple mask stop you from doing what will undoubtedly save lives. Thank you so much for your vote of "YES" on this measure. 





To Clerk of the Board (for Inclusion in The December 21 Meeting Minutes) Although I thought the issue of mandatory masking had been settled, apparently that is not the case. Therefore I am writing again to let you know that I do not support such a mandate. Are there any scientific reasons to mask? No. Random clinical trials have concluded there is no scientific evidence supporting facemasks' efficacy. They do not prevent people from exposure and infection with this or any virus. All masking seems to be good at doing is helping people feel like they have some control over this supposed pandemic and COVID-19. It has become a security blanket and/or pacifier for those who are so frightened about a virus that is less deadly than the flu for which no masking is required except during the 1918-1919 influenza pandemic and they did not work then either. Masks have been shown through overwhelming clinical evidence to have no effect against transmission of viral pathogens. Remember the SARS-CoV 2 virus is smaller than the pores in the masks so masks cannot filter out the virus whether you are coughing out Comment viral particles or someone else is. The virus is everywhere now, so it is no surprise that

the outside of the masks can become colonized with the virus from the environment and as a masked individual breathes drawing in air while talking or simply breathing, they are pulling in portions of the mask colonized with the virus. The bacteria (normal oral flora) found in the upper respiratory tract of humans increases in number when wearing a mask. The inner side of the mask becomes colonized with the bacteria which are breathed back into the individual. These bacteria as they concentrate can move from the upper respiratory tract down into the lower respiratory tract, the lungs, and cause secondary infections. This increase in bacteria can also cause more dental caries, gum disease, and abscess over time. How many people change their masks or clean them regularly? How many people adjust the mask, touching the outside of it or pulling it up and down, taking it off and putting it back on? They are handling the mask with contaminated fingers gloved or otherwise, contaminating the mask that is supposed to protect them. The best way to cut down on viral transmission is to practice good hygiene. Wash your hands

before touching your face. Wash your hands when you come back from shopping at a store. Stay home if you do not feel well. Get fresh air (no mask worn) and here in Arizona, open up some doors and windows and let fresh air in. Masking does not cut down on transmission of the virus but it certainly causes other less than positive consequences. Allow each individual to choose whether they want to use a mask or not.
