Introduction/Background:								
rer A.R.S. §16-411(A), The board of supervisors of each county, on or before October 1 of each year preceding the year f a general election, by an order, shall establish a convenient number of election precincts in the county and define the oundaries of the precincts. The election precinct boundaries shall be established so as to be included within election istricts prescribed by law for elected officers of the state and its political subdivisions including community college district recincts, except those elected officers provided for in titles 30 and 48. Although the Board has already decided not to hange the number of election precincts prior to the 2022 Election Cycle, the Elections Department is requesting that the loard approve several precinct line adjustments and new precincts as a result of recent actions by the Arizona independent Redistricting Commission								
Discussion:								
The Arizona Independent Redistricting Commission finalized the new Congressional and Legislative maps on January 21. The new lines caused the need for precinct line adjustments to 70 precincts and the creation of 29 new precincts. The additional precincts were caused by the new Congressional and Legislative Lines and the current Supervisor/Pima Community College and Justice of the Peace Lines creating "islands" of land that cannot be combined with other precincts.

Re: Arizona Independent Redistricting Committee Voter Precinct Splits

Recently the Arizona Independent Redistricting Commission (IRC) tentatively approved new congressional and legislative districts. Similar to the last IRC effort 10 years ago, the Commission's new districts split voter precincts. As a result, the Elections Department, with the assistance of the IT Department, is reviewing each split and creating a number of new precincts to align with the new districts. These precincts will require approval by the Board of Supervisors and will then be transmitted to the Recorder's Office so that the Recorder can notify voters of their new precincts and districts in preparation for this 2022 election cycle. The Recorder's Office will be sending out new voter registration cards to the 625,000 registered voters, countywide, which will detail each voter's new congressional and legislative districts.

Voter precincts are also the building blocks for Board of Supervisor/Pima Community College redistricting, and therefore the sooner these minor precinct additions can be approved, the better. The Board appointed Redistricting Advisory Committee will be encouraged not to split voter precincts and to complete their task of recommending revised districts to the Board in April so that the Board can approve them in May. The Recorder's Office has requested that no changes be made to the voter registration system after that in order to prepare for the 2022 election cycle. Early voting for the primaries begins on July 6. The Elections Department, Recorder's Office, IT Department and Communications Office are working together to coordinate communications to inform the public of these important changes.

Final approval of the new congressional and legislative districts by the IRC is anticipated at their next meeting scheduled for January 18. The Elections Department is aiming to transmit these minor voter precinct additions to the Board for the February 1 Board meeting.

2022 LEGAL DESCRIPTIONS

PRECINCT 1

- Beginning at the intersection of the northeast corner of Section 1, T 11 S, R 5 W and the Pima-Maricopa County boundary line;
- Thence, West along the Pima-Maricopa County boundary line to the northwest corner of Section 6, T 11 S, R 6 W;
- Thence, South along the Section lines to the southwest corner of Section 31, T 12 S, R 6 W;
- Thence, East along the Section lines to a point 10 feet west of the east Section line of Section 36, T 12 S, R 5 W;
- Thence, North 10 feet then East 10 feet to the east Section line of Section 36, T 12 S, R 5 W;
- Thence, North along the Section lines to the northeast corner of Section 1, T 11 S, R 5 W, the point of beginning.

PRECINCT 2

- Beginning at the 1/2 Section line T 11 S, R 3 W, such point being coterminous with the west Tohono O'Odham Indian Reservation boundary line and the Pima-Maricopa County Boundary line;
- Thence, West to the northeast corner of Section 1, T 11 S, R 5 W;
- Thence, South along Section lines to a point 10 feet north of the south Section line of Section 36, T 12 S, R 5 W;
- Thence, West 10 feet then South 10 feet to the south Section line of Section 36, T 12 S, R 5 W;
- Thence, West following Section line to the southwest corner of Section 3, T 12 S, R 6 W;
- Thence, North along the Section lines to the Pima-Maricopa County Boundary line;
- Thence, West along the Pima-Maricopa Boundary line to the Pima-Yuma County Boundary line;
- Thence, South along the Pima-Yuma County Boundary line to the Pima County-Mexico International Border line;
