This appointment limits the exercise of the powers granted under ARS § 22-121 to those occasions where the Pro Tempore Justice of the Peace is scheduled on the Pima County Consolidated, Green Valley or Ajo Justice Court docket and not for any other purpose or function, whether mandatory or discretionary.
