I, Rafael L. Polo, request this comment be read into the record at the next Pima County Board of Supervisors Meeting (15 February 2022).

The Pima County Elections Department and the Pima County Recorder's Office are proposing a major change to the way we vote in Pima County. Four months before the Primary voting season starts on 6 July 2022, Pima County Elections and Recorder want to change the number of voting locations and the technology and rules of operations of the polling locations.

This Pima County Elections Department proposed change is evildoing. During the 2020 election, several states changed their voting format shortly before the election, using the COVID pandemic excuse, to promote their ideological self-interests. The result was an election that left millions of de-franchised voters feeling cheated that their legal vote did not count. The legal voters of Arizona and specifically Pima County cannot be subjected to another sham election.

The proposal calls for a 57% reduction in Voting Precincts/locations from 232 to 100 for the entire county. The proposal is also pushing to utilize Federally uncertified Electronic Pollbooks (tablets with access to the county's voter rolls) from Apple that are connected to the internet as well as wireless ballot printing devices. Their goal is to turn over the security of Pima County elections to third party vendors like Amazon Web Services, Cisco, and Tenex Software Solutions. Again, that proposal is evildoing.

The above is a recipe for corruption. One legal citizen, one vote is out the window. Instead, the opportunity for illegal voting is wide open.

Election Day is a one-day ritual. At the end of the day or late evening we should know who the winner is. We should not have to wait days or even weeks to know who won and who lost.

Reducing Voting Precincts by 57% makes it harder to vote and easier to cheat. Since there are less Voting Precincts one can expect longer lines at the polls. One can predict that the Board's next step to alleviate long lines at the polls will be more mailing ballots. We have all witnessed what a corrupt practice that was in the last election. We cannot be fooled again. As the saying goes: "Fool me once shame on you, fool me twice shame on me."

I served in the military for twenty years. No matter where I was stationed, overseas, or stateside, I always voted because I requested an absentee ballot. If someone wants to vote by mail, then, request an absentee ballot.

Finally, I lived in Peru for two years (1985 and 1986) and Brazil for three (1992, 1993, and 1994). Every citizen had a "carnet." The carnet detailed all information regarding that private citizen information, from when and where he/she was born to their current address. There is no mistaking who that person was when it came time to vote.

I'm requesting my comments below be read into the record at the next Pima County Board of Supervisors Meeting:

Supervisors' Scott, Heinz, Bronson, Christy and Grijalva

I spoke with the Elections Director and Recorder last month. They each stated their major concern with the upcoming election was the public's view of the office, and voter confidence. So why would Pima County even consider making major changes to our accessible polling places and pollbooks?

Maricopa County implemented both Voting Centers and E-Pollbooks. Consequence, in-person voters suffered with wait long lines in 2020. This isn't unusual when counties implement Voting Centers and e-Pollbooks. Some states in 2020 experienced waits as long as 8 hours. Long wait lines aren't the only problem with these centralized processes. Voting Centers cause confusion on where to go, and they force voters to be in crowded spaces sometimes with thousands of people. This alone is a major health and safety issue.

Isn't Pima County Board of Supervisors supposed to act in the best interest of its citizens? Why then would Pima County purposefully disenfranchise low-income and disable in- person voters? These groups often have limited transportation options, and less time or flexibility to vote.

E-Pollbooks are equally a disaster. E-Pollbooks are connected to the internet, easily hackable, no uniform standards, or federal certification. E-Pollbooks have contributed to chaos in multiple states with their malfunctions, which has caused excessive delays preventing people from voting. Voting Centers and E-Pollbooks separately or together equal the definition of Voter Suppression.

In addition to all the above reasons for not approving Voting Centers and E-pollbooks, there simply isn't enough time to implement these major changes for the 2022 election. The Pima County Election Integrity Commission listed 6 additional substantial processes and funding that need to be in place prior to the 2022 election, which by the way is only months away.

I understand more automated and centralized from a business perspective sound great on paper, but really are elections intended to be convenient for the Counties that run them? I ask that the Board of Supervisors to remember that elections in the United States were purposely structured to be decentralized, accessible, accountable, and above all for the voters, not the government.

I also ask the Board of Supervisors to strongly consider what your Recorder and Elections Director stated they were most concerned with in the upcoming election: Voter confidence and the publics view of their office. Earn back the trust of voters by ensuring our local Precinct voting locations aren't consolidated, and there's no change to our paper Pollbooks.
