Precinct voting locations are much more voter-friendly than their counterpart, Voting Centers. As a 25-year resident of the Catalina Foothills area, my precinct voting location is just down the street, minutes away. In several past years I have walked with family and/or friends to our precinct voting location to cast our ballots. We receive excellent service from the Poll Workers who sometimes know me or recognize me from previous years.

This rapid change just 6 months prior to the primary elections with little or no notice or comments is not conducive to building a working understanding of the issues and operations of these proposals. I strongly support the use of voting centers for elections.

I worked at the polls on election days for several years. Many people were confused as to which precinct they should vote in, especially if they had recently moved. We poll workers tried to help figure out their correct precincts, but sometimes had to resort to provisional ballots. In some cases, we knew a voter had come to the wrong precinct, but when the voter could not get to the polls until after work, there often was not enough time to get to the right precinct to vote. Both poll workers and voters were frustrated by this disenfranchisement, which was largely beyond our control.

Voting centers are a common sense solution to a longstanding problem. They will allow voter access and faster ballot counting.

Hi. My name is Ricky Sage, I am a resident of Tucson. I was brought up to believe that voting is a civic duty, that government "of the people, by the people, and for the people" has been consecrated by the sacrifice of patriots as described by Lincoln at the Gettysburg address. So, while I have never missed a major vote, I have on occasion waited in lines that lasted for hours. I have missed work. I have had to drive a long distance from work to my local precinct polling location, and barely made it before the polls closed. A system of voting centers is such a good idea that the majority of Arizona counties have already adopted such a system.

Convenient voting is not fraudulent voting, in spite of what some claim.

Government has a responsibility to make voting accessible to all eligible voters.

There is no partisan advantage to efficient voting. The current early voting system is utilized by nearly 90% of voters in Arizona according to news reports.

Those who speak against efficient voting are attempting to sow distrust about our democratic systems. There are existing checks in the system to prevent fraudulent votes, and to hold uncertain ballots in "escrow" until the validity can be ensured. There is no reason to be afraid of using widely available and proven technology to make voting easier for the masses, and in particular for those who have to work on voting day, and may not have access to transportation to get to their local home polling center before the

polls close. But in general it makes voting more accessible to all voters regardless of economic, employment, or transportation status.

I give my full support this common sense proposal, and hope that you as well support making civic participation more open!

Dear Board of Supervisors:

I have 20 years experience working in the polls during various kinds of Elections. In 2020 I was an Inspector for the Primary and General Elections in Pima County. I am very concerned about the Pima County Elections Department's and Recorder's Office's proposal to implement Voting Centers, Electronic Pollbooks and Ballot Printers starting July 6, 2022.

Our Mission as Election Officials is to implement a free and fair election in which the citizens of Pima County can believe and can accept the results.

I am concerned this mission is in serious jeopardy. Roughly four months before the 2022 voting season begins, the Elections Department and the Recorder's Office want to:

1. Create Voting Centers by reducing the number of Voting Locations by 57%, from 232 to 100. This does not take into account the 30 new precincts that were recently proposed during the last BOS meeting. This would also REVERSE THE DECISION THAT THE BOARD OF SUPERVISORS TOOK LAST SEPTEMBER TO KEEP THE NUMBER OF PRECINCTS AT 249.
2. Install new voting equipment in the Voting Centers including Federally uncertified Electronic Pollbooks (tablets with Voter Rolls) from Apple that are connected to Amazon Web Services as well as ballot printing devices. They want to turn over the security of Pima County elections to 3rd party vendors AWS, Cisco and Tenex Software Solutions.
3. Change the rules of operation for voters and poll workers.

ALL AT ONCE! BY JULY 6, 2022!

VOTERS' CONFIDENCE IS AT STAKE AT A TIME WHEN WE NEED THEM TO BELIEVE THAT WE ARE COMPETENT AND FOLLOWING THE LAW.

Here are my reasons for concern:

1. This Proposal does almost nothing to increase Pima County Voters' confidence in our Elections. If anything it DECREASES it. Voters are skeptical about any device that can be remotely connected to other systems. ANY SYSTEM CAN FAIL OR BE HACKED. No vendor can guarantee 100%

uptime. Pima County will need paper ballots and paper rosters as back up to keep the Election going if something fails.

2. Most Pima County Voters are aware that Maricopa County conducted an election in 2020 with questionable results. Maricopa implemented Voting Centers as described above. Real vulnerabilities in Election processes were discovered as a result of the Maricopa County Audit in 2021. There are **37 Election Integrity Bills** currently in the State Legislature to fix these problems. Among them are bills mandating, statewide, **MORE PRECINCTS, LESS TECHNOLOGY, BETTER VOTER ROLL MAINTENANCE, AND MORE SCRUTINY BY ELECTION OFFICIALS.** Why would Pima County recommend the same implementation as Maricopa's if it caused this much legislative attention? Obviously, if some of these measures become law, Pima County will be out of step.

3. How does reducing voting locations by 57% engender trust from voters in our elected and appointed officials? On its face, the reduction in Voting Locations is making it less convenient for people to vote or to drop off their Early Ballots on Election Day.

4. The Recorders Office has new leadership. The Elections Director has just left and the assistant director is leaving in April. Will this team be able to deliver?

For example:

a. Can we trust that the training of all involved will be detailed and grounded in ARS- 16 Election Laws? In the 2020 Primary and General Elections, Poll Worker training was delivered in person to Inspectors and Marshals in 20 minutes. The training for Clerks and Judges was on-line. If we have inconsistent practices across voting areas it makes voters skeptical and creates a liability for the county.

b. Can we trust that the Voter Rolls will be 100% accurate? The most serious issue we dealt with in my location were numerous voters who were marked in the Roster as having received an Early Ballot when they NEVER requested one and ALWAYS vote in person. They voted Provisionally. They were devastated. They didn't believe their votes would be counted. **This problem would NOT have been eliminated by an Electronic Poll Book.**

c. Which Election Official will be accountable for this project involving voters, poll workers, vendors, new poll locations and new technology? Where is the plan? Will it fall to Apple, Amazon, Cisco and Tenex? What about deliveries?

d. If the results of the Elections are challenged, how will it be determined which part failed? The Voter Rolls? The EPollBooks? The Poll Workers?, The Ballot Printers? The New Locations? The Network?

In sum, in a time very much like the Bush v. Gore Era - - the era of the HAVA Act, ironically - -I believe there is tremendous risk in a complete redesign of our Election Day operation. Pima County right now is the envy of the Arizona State House with our small precincts, paper ballots and hands on attention. There are many other ways to make improvements. Just ask.

Please don't THROW THE BABY OUT WITH THE BATHWATER!

(Read only if there is time: **AN INTERESTING LITTLE FACTOID**: One of the proposed conveniences of Voting Centers is that voters will be able to vote in ANY one of the 100 polling locations. The Proposal states that “thousands” of voters voted out of precinct and their votes didn’t count. By their own admission, the Elections Department reported that in the 2020 General Election out of 665K registered voters, only 653 voters didn’t vote in the correct precinct. Supervisors,

We all remember the images of women in full body coverings holding up ink-stained fingers. You didn't need to be supporter of the Iraq or Afghanistan Wars to be moved by those images... Images that spoke of the most basic of human needs... the need to be heard... that my voice matters!

We speak about the Right to Vote but in a free, self-governing society. We forget there is another component that goes with that Right... The Responsibility to Vote. As the Pima County Board of Supervisors your responsibility is clear. You are the folks designated to maintain the basic mechanics of the election process in Pima County. Through the Elections Department you administer the balloting process from end to end... from the printing of the ballot right on through final tabulation and publishing a canvas of the results. Your duty is to maintain the systems to allow for the full expression of the Right to Vote... but in your haste to be more efficient and speedier you are sacrificing your responsibilities and endangering the civic health of our community.

When a citizen votes, they don't just fill in the bubbles on the ballot. Able bodied citizens have a responsibility to publicly affirm the process. This does not mean we do away with the traditional reasons for casting an absentee ballot. If you are unable to get to a polling location in your neighborhood the law allows you to cast an absentee ballot. What we cannot forget is the reason why casting a ballot in person is so critical to the maintenance of our civic culture.

What other Right do citizens have that has a regular appointment to exercise their Constitutional Rights as when they vote? The public affirmation of voting is done in front of your neighbors and fellow citizens at the local, neighborhood level. In a representative form of government this means that the citizens of a given area come together and vote for the person that votes for laws on their behalf. They are voting for their neighborhood community representation.

Doing so in their local precinct... together and witnessed by their fellow citizens is a necessity and has a healthy and reinforcing action to our civic culture. This community action can only occur when voting happens in your local neighborhood precinct. It cannot be done by community wide Mail-in Voting nor by large Vote Centers.

We vote according to our individual thoughts and ideas about the ballot contests in the privacy of the voting booth. When we are done, we insert the ballot in the ballot box because this simple, public act does remind both the citizen and the government officials present that it is the citizen that is in charge. This action endorses our system of voting for our representatives and helps to maintain our civic culture. It reaffirms why it is necessary to come together as a local community to vote for OUR representatives... and that voting is publicly witnessed by our neighbors.

The use of a Vote Centers denies the citizens the opportunity to have their public affirmation of the voting process remain at the local level. While a Vote Center may be more efficient, it distances both the neighbors in a community

from one another and dilutes the power of the public affirmation at the local level. In the end the only true beneficiary would seem to be the bureaucracy.

In your rush to make speed or convenience the goal, you will sacrifice the very personal reminder to our neighbors that we are voting for our local representatives. You will be further distancing the citizens from the government. This is a recipe for disaster.

Your job as the Board of Supervisors is to maintain not just the machinery of our elections but to guard against any loss of the strength of our voting systems. The first duty of government is to protect the Rights of the Citizens. This is enshrined in both the Arizona and US Constitutions. Like those burka clad women, the citizens of Pima County need their voices to be heard. Not just in this November's election... but in every election. But your haste would seem to make voting in Pima County more of a bureaucratic function and less a Right... You would in fact be saying our voices don't matter.

Do not vote to initiate Voting Centers in Pima County.

Vote centers will allow any registered voter to vote at whichever center is closest to them whether from work or home. It will increase turnout by making voting more accessible and convenient.

It will lessen the need for many poll workers and volunteers who may be unavailable to man the Precinct locations which causes those locations to be unavailable.

Many Arizona counties already use the vote center model.

Make voting easier, vote YES on vote centers.
