Re: Additional Information – Continued Item of the February 15, 2022 Board of Supervisors Meeting – Item 12, Extension and Expansion of Pandemic Outbreak Leave

At the February 15, 2022 Board of Supervisors Meeting, the Board continued Item 12, Extension and Expansion of Pandemic Leave to the March 1, 2022 meeting and asked for further information. The information below has been gathered by Human Resources, Finance and Analytics & Data Governance staff.

#### **Current Status of County Pandemic Outbreak Leave I**

Approximately 6,500 employees received Pandemic Outbreak Leave I. Of those 6,500 employees, only 2,291 have remaining Pandemic Outbreak Leave I balances as of pay period ending January 29, 2022. These balances range from one (1) hour up to eighty (80) hours. Any County Pandemic Outbreak Leave I that an employee has remaining is in a separate leave bank identified as Pandemic-Vacation leave. Currently, this leave can be used for any purpose and must be used by the employee's anniversary date in 2023, at which time it will convert to sick leave. Any employees who previously utilized their County Pandemic Outbreak Leave I were paid at their current salary, for a total salary cost of approximately \$8.8 million. Additionally, any employees who left the County and had this leave available, received the remaining leave paid at their current wage rate. This totaled to approximately \$369,000.

#### Options for Remaining County Pandemic Outbreak Leave I Include:

The options provided below are made with the objective to ensure that all employees are treated equitably in regards to the use and/or payment of Pandemic-Vacation leave that has not been previously used.

On July 6, 2021 Human Resources received authorization from the County Administrator to Convert Pandemic Outbreak Leave to Annual Leave Upon the end of the Declaration of Emergency to employees who have been employed with the County since June 30, 2020.

#### Option A

This option provides that employees be given the choice to either retain their Pandemic-Vacation leave or receive a payout at 100% of their base salary. For those employees who would like to exercise their payout option, employees would submit their request to Payroll

by April 1, 2022, for payment on their April 15, 2022, paycheck or at the time of their separation from the County.

#### > Option B

This option provides that the current process remains in effect and that no option be available for payout of the leave while employed with the County. The 2023 expiration date for usage would be eliminated and the hours would not convert to sick leave but remain in the employee's current Pandemic-Vacation leave bank. Employees who leave the County would receive any remaining leave paid at their wage rate at the time of separation.

#### > Option C

This option provides that the current process remains in effect and employees be given the choice to either retain their Pandemic-Vacation leave or receive a payout at 50% of their base salary. For those employees who would like to exercise the 50% payout option, employees would submit their request to Payroll by April 1, 2022, for payment on their April 15, 2022, paycheck or receive 100% of their wage rate at the time of their separation from the County. Any remaining Pandemic-Vacation leave balances after the employee's anniversary date in 2023 will be rolled into Sick leave.

# What Funding Will Cover the \$4.4 Million Needed for the Payout Option and What is the Breakdown of the \$800,000 Employee Related Benefits

If employees were to be paid out for this leave under Option A, the cost would be \$4.4 million, which would be funded from the department in which the employee resides. Should the employee utilize the time while working for the County, there is no additional cost to the department as the amount is already provided for in the department's funding. Table 1 represents the estimated costs by fund and the associated employee related benefits (i.e., Retirement and Social Security and Medicare taxes) paid by Pima County if all 2,291 employees were to choose to receive a payout of this leave.

#### Remaining Recipients of the County Pandemic Outbreak Leave I

As stated earlier, approximately 6,500 employees have already received Pandemic Outbreak Leave I, only 2,291 employees have remaining balances. The remaining available hours range from one (1) hour up to the maximum of eighty (80) hours and include employees from approximately 476 different job classifications. The attached table identifies the classifications of these 2,291 employees.

Additionally, of the 2,291 employees with remaining balances, only 66 employees previously received hazardous pay (i.e., temperature taker and election hazard pay) for working during the COVID-19 pandemic for a total of about \$20,500. This pay was paid from ARPA Funds for eligible workers who maintained continuity of operations of the essential critical infrastructure of the County.
