***Project Title/Description:**

Mobile Connections Telehealth Pilot

***Purpose:**

Pima County Public Library (PCPL) will purchase three (3) telehealth and remote patient monitoring kits. These kits which will be utilized in the Salazar-Ajo Library, the Caviglia-Arivaca Library, and the third kit will be used as part of a mobile outreach unit, allowing PCPL to deliver access and service to community members in rural areas, and to those outside of traditional programming boundaries.

***Procurement Method:**

Not applicable to grant awards.

***Program Goals/Predicted Outcomes:**

The goal of this program is to provide access to equipment that positively affects healthcare outcomes and work on innovative ways to transform healthcare delivery to outlying communities who traditionally have barriers to access.

***Public Benefit:**

Residents in Arivaca and Ajo, will have access to telehealth and remote patient monitoring supplies. Community members will be able to utilize the equipment in conjunction with telehealth visits they schedule with their own primary care physicians. A mobile outreach kit will be available used during outreach events to improve awareness of and access to important healthcare resources.

***Metrics Available to Measure Performance:**

Non-personally identifiable data such as the total number of reservations, number of equipment uses, and number of patrons served will be collected on an ongoing basis and will be used for reporting to the Arizona State Library as a means of pilot evaluation.

***Retroactive:**

Yes. Funding period for Library Services and Technology Act projects pilot began with letter of award February 15 -- Library District will request funds according after Board approval.

Assurances and Certifications for 2021 Arizona LSTA Subgrant Award

1. Nondiscrimination
