***Purpose:**

Contractor will provide one-to-one tutoring in math, English, social studies, and electives studies, to formerly out-of-school youth. Pima Vocational High School (PVHS) has been affected by the nationwide teacher shortage and turnaround within the school. This amendment will provide additional funds for the use of academic tutoring services, as needed, in various subjects, for the 2021-22 school year. The tutor will be evaluated by the PVHS program coordinator, by reviewing student academic improvement, measured by weekly comprehension assessments, course final exams, and state standardized tests.

PROFESSIONAL SERVICE CONTRACT – AMENDMENT THREE

The parties agree to amend the above-referenced contract as follows:

1. Background and Purpose.

- 1.1. Background.** On July 1, 2020, County and Joseph M. Casey ("Contractor") entered into the above referenced agreement to provide substitute teachers for Pima Vocational High School, ("PVHS").
- 1.2. Purpose.** Due to the COVID-19 Pandemic and nationwide teacher shortage, County requires additional academic tutoring services for the 2021-2022 school year. This amendment will provide additional funds for tutoring services to support students during the 2021-2022 school year.

2. Maximum Payment Amount. The maximum amount the County will spend under this Contract, as set forth in section 5, is increased by \$12,000.00. Paragraph 5.2 is amended to increase the NTE Amount from \$76,500.00 to \$88,500.00.

3. EXHIBIT B – Compensation and Payment. Paragraph 1.1 is amended to increase the number of hours from 1400 to 1880.


