Amendment of Award: Master Agreement No. MA-PO-22-026, Amendment No. 02. This Amendment increases the award amount by \$250,000.00 for a cumulative not-to-exceed contract amount of \$500,000.00.

#### \*Procurement Method:

Pursuant to Pima County Procurement Code 11.12.060, Emergency and other limited competition procurement, on August 13, 2021, the Procurement Director approved an award of contract for an initial term of six (6) months in the not-to-exceed award amount of \$250,000.00 with four (4) six-month renewal options.

Effective February 16, 2022, the Procurement Officer processed Amendment No. 01, which extended the termination date to August 15, 2022. No additional funding was added and contract no-to-exceed amount remained at \$250,000.00. Three (3) renewal options remained.

The award increase is needed to continue services provided pursuant to this contract.
