Arizona Coronavirus Emergency Supplemental Funding Program

***Purpose:**

The Arizona Coronavirus Emergency Supplement Funding (ACESF) Program allows support of a broad range of activities to prevent, prepare for, and respond to the coronavirus which may include, but are not limited to, minimizing personal contacts, maintaining social distancing, sanitizing surfaces and equipment wherever possible, and allowing some of its staff to work from home. The program provides overtime, equipment (including law enforcement and medical personal protective equipment), hiring, supplies (such as gloves, masks, sanitizer), training, and travel expenses (particularly related to the distribution of resources to the most impacted areas). These amendments are to increase the award by \$18,256.30 and to extend the term until 01/31/2023.

***Program Goals/Predicted Outcomes:**

We are grateful for the previous funding support and request trimmed down annual estimated funding for 12 monthly cell phone services payments for Victim Services, 12 monthly MiFi Jetpack Services for Internet connectivity, 48 weeks of Vehicle Disinfection Services for 15 vehicles used to transport victims and witnesses to appointments and other services, and 300 K95 masks to assure continued protection of its staff, volunteers, and the public it serves.

Pima County Attorney's Office will continue serving and protecting the public, while minimizing the risk of exposure

Monthly financial reports, quarterly statistical reports, and semi-annual narrative progress reports.
