**Subject:** Board of Supervisors Agenda Item Modifications to Employee COVID-19 Vaccine Requirement.

Pima County is claiming that the unvaccinated employees are not safe to the public or other co-workers. It is a known fact that **vaccinated** people still **get and spread COVID-19**. In fact, BioNTech, the European company behind Pfizer's COVID-19 vaccine, says in its annual report to the US Securities and Exchange Commission "We may not be able to demonstrate **sufficient efficacy or safety of our COVID-19 vaccine** ... to obtain permanent regulatory approval in the United States, the United Kingdom, the European Union, ..." [Form 20-F, Section D. Risk Factors, p. 6]. Also, Pfizer's release of information regarding the COVID-19 vaccine shows **1291 known adverse side effects** that were kept a secret up until recently when a judge ordered Pfizer to release their COVID-19 vaccine information. Side effects include, but are not limited to, acute kidney injury; anti-sperm antibody positive; brain stem embolism and thrombosis; cardiac arrest and failure; death neonatal; frontal lobe epilepsy; immune-mediated hepatitis; juvenile myoclonic epilepsy; multisystem inflammatory syndrome in children; myocarditis, genital herpes, arrhythmia; progressive multiple sclerosis; premature menopause; rheumatic brain disease; thrombotic stroke; and the list goes on.
