THIRD AMENDMENT TO MASTER AGREEMENT FOR WIRELESS COMMUNICATIONS FACILITIES AND SITE-SPECIFIC SUPPLEMENTAL AGREEMENTS FOR SPECIFIED LOCATIONS

A. County and Licensee entered into a Master Agreement for Wireless Telecommunications Facilities and Site-Specific Supplemental Agreements for Specified Locations dated May 17, 2016, (the "Agreement"); and

B. The Master Agreement included five (5) Site-Specific Agreements ("SSA's") and the parties added an additional SSA #6 in Amendment No. 2 on December 7, 2021.

C. This Agreement expires on June 5, 2025 pursuant to Amendment No. 1 and Licensee wants to extend the term of the Agreement for three (3) SSAs, (specifically SSA #2, 3 and 4) for an additional five (5) year term and County is agreeable to the requested term extension;

NOW, THEREFORE, the parties agree as follows:

- 1. The effective date of this Third Amendment shall be the date this Amendment is approved by the Pima County Board of Supervisors.
- 2. The term of the Agreement in Section 7 of the Master Agreement is renewed for an additional five-year term to expire on June 5, 2030. The parties are only renewing three (3) SSAs and those SSAs are attached to this Amendment.
- All other provisions of the Agreement and of all the SSAs not specifically changed by this Amendment shall remain in effect and are binding on the parties.


