Supervisor Christy, My name is Mary Grace Werner. I live at 4442 S Golf Estates Drive, Green Valley Az 85622. I am writing to you to comment on Recommendations for Election Workers and the Covid-19 Vaccine Mandate, #4 on the addendum. First let me share a personal aside. I filled out the form I received from Pima County indicating I was interested in working the elections, I said I would be willing to work on the elections in any capacity and would be willing to be an Inspector if provided with training. I received a phone call from Pima County in May asking if I would be willing to be the Inspector at the Desert Hills Community (Social) Center in Green Valley and I said I would as long as Comment I was trained. I was asked if I was vaccinated and truthful as I am, I replied I was not although I had had Covid. A few weeks later, I received a voice mail message from Pima County telling me I was not able to work the elections as I was not vaccinated. I now see Pima County is willing to make some concessions about vaccinated and unvaccinated or unknown workers working the elections. I have read the recommendations for Election Workers and I have some question/concerns. Item 1: Election Workers and symptoms of Covid-19 – symptoms COVID-19 within 48 hours of their scheduled start time. This is allergy season and several people have serious allergies that result in coughs, stuffy nose, sore throat, and headaches. Within 48 hours of the election, how will you know these symptoms are not due to allergies versus COVID-19. Not allowing these individuals to

work the election could significantly affect the numbers of people who will be at the voting centers. Will you have trained replacements readily available? Item 2: Between 24 and 36 hours prior to the start time, Election Workers shall provide proof of a negative test for COVID-19. Who will cover the cost of this test? How will this test be performed - by PCR or test kit? If by PCR, what is the threshold set for this test? If it is a test kit, is it one that does not provide false positive results? Item 3: Offering a \$50.00 stipend for those Election Workers who are vaccinated is discriminatory. I am sure by now you know that the vaccinated carry as much or more of the virus in their upper respiratory tracts than the unvaccinated and have more breakthrough infections than do those who have had natural infection. If workers are concerned about their health, let them wear a mask (which supposedly protects them), social distance (the value of which is questionable), and do frequent disinfection of work site counters. This may help the election workers to feel safer although the virus is ubiquitous not just in and on work surfaces and human hosts. Individuals will come into the voting center to vote and you will have not idea if they are vaccinated, asymptomatic carriers, or have symptoms of COVID-19 but yet you are requiring election workers to be strictly controlled and tested. This seems rather disingenuous. I am concerned, you may not have enough individuals capable and willing to work the elections especially those who need to be there for 12-14 hours on election day. I am a retired Clinical Laboratory Scientist with specialities in Medical Microbiology and Immunology in case you are wondering if I know what I am talking about. You may want to rethink the strategy. I suggest you let the testing and the stipends fall by the wayside. Supervisor Christy, I hope this will give you some "food for thought." Thanks for listening.
