INTERGOVERNMENTAL AGREEMENT AMENDMENT THREE

1. BACKGROUND AND PURPOSE.

- 1.1 **Background.** On May 21, 2019, Pima County ("County") and City of South Tucson ("City"), entered into the above-referenced Intergovernmental Agreement ("Agreement") to provide youth programs and recreation activities.
- 1.2 **Purpose.** County operates a workforce development program at Pima County ARIZONA@WORK (an American Job Center, formerly the Pima County One Stop). Pima County Board of Supervisors finds that JVYC activities will enhance academic performance, economic opportunities, and fitness of youth participants.

2. TERMS AND EXTENSIONS.

Pursuant to Paragraph 2.2 of the Agreement, County extend the Agreement for an additional one-year period. The Agreement will terminate on June 30, 2023.

3. COMPENSATION AND PAYMENT.

Paragraph 3.1 of the Agreement is amended to increase County provided funding from \$339,000.00 to \$452,000.00.

4. SCOPE OF SERVICES.

The Commencement Date for this Amendment No. 3 is July 1, 2022.

5. COUNTERPARTS.

This Amendment may be executed in counterparts, each of which, when taken together, will constitute one original document.

All other provisions of the Agreement not expressly modified in this Amendment will remain in effect and be binding on the parties.
