Dear Humane Agency:

The Arizona Companion Animal Spay/Neuter Committee has reviewed all grant applications. Sixty-Five (65) programs will benefit from the \$410,000 disbursed for the 2021-2022 Grant Period. You have been selected to receive grant funds restricted to increasing spay and neuter efforts in your community in the amount of **\$5,000.00 for your Public Spay/Neuter program. These funds must be used for spay/neuter surgeries only. Your check will come in the mail from PETsMART Charities.**

These grant funds were made available from the support and sales of the Arizona Companion Animal Spay and Neuter Pet Friendly License Plates. As such, we ask you to promote the Spay and Neuter License Plates through newsletters, websites, and media events. We encourage you and your staff to purchase the plates for your vehicles, too. The 2017 tax year was the first year that the State of Arizona allowed taxpayers to donate to this fund via their tax forms, please inform your community and encourage them to do so.

The first report of grant expenditures must be postmarked no later than May 30, 2022 or within thirty (30) days of full expenditure, whichever comes first. All funds must be expended by August 15, 2022. A final follow up report must be postmarked by August 15, 2022.

When reporting, please include copies of your license plate promotional materials and any vouchers or coupons you use. A reporting worksheet, also to be returned, is enclosed. Future grant opportunities do depend on the timeliness and thoroughness of your report.

The Arizona Companion Animal Spay/Neuter Committee will be placing your contact person information on the AZPETPLATES.ORG web site as agreed at the time of application. The information you provided on your application will be used unless you prefer to provide us with a different contact person.
