Having a homeless liaison on-site at PVHS will ensures that homeless students have the support necessary to succeed and obtain their goal of receiving a high school diploma.

#### \*Metrics Available to Measure Performance:

Employee evaluations completed by the PVHS program coordinator, employee time and duty sheets submitted bi-weekly. In addition to, data exported and notes entered into Multi-Tiered System of Supports (MTSS) data system, Panorama, documenting services and interventions for PVHS homeless students.

The Youth Specialist works directly with students to set weekly goals for class attendance, resolving teen parenting, court-involved and homeless issues which are barriers to regular attendance and academic success. The Youth Specialist works closely in reviewing individual class completions and monitoring improvement in academic assessments. Refers students to additional resources such as tutoring and emergency assistance. This is a full time position that is split funded by Title IVA (15%), Classroom Site Dropout Prevention (40%) and County Support(45%) (\$50,788\*0.15 = \$7618) (Reduced to \$6669.74 based on available funds)

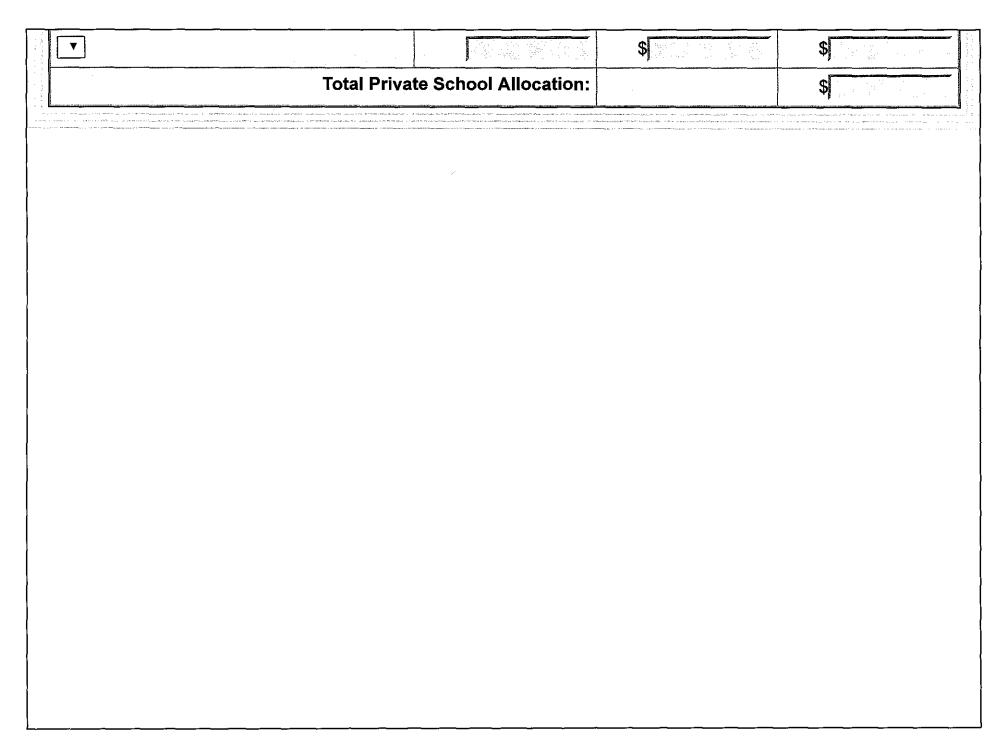
