Compass Affordable Housing, Inc.

*Project Title/Description:

Arizona Department of Housing - Pima County Links Rapid Re-Housing. This is a housing and employment program for people experiencing homelessness in Pima County.

*Purpose:

Arizona Department of Housing (ADOH) has awarded State of Arizona Housing Program funds to the County for 2021-22. Compass Affordable Housing, Inc., a subrecipient, will provide rapid re-housing to homeless households and prevention for households who are at risk of becoming homeless. After program participants have been stabilized in housing, they will enter Sullivan Jackson Employment Center for the Homeless (SJEC) to find full time employment and begin to live independently within six months. The target population served includes households with children and households transitioning from homelessness, caused by a variety of issues all who are without housing, family and financial resources or support. This amendment extends the term through December 1, 2022 and allows for additional time to spend down the remaining funds on the grant. This is a no-cost amendment.

*Procurement Method:

This Subrecipient Agreement is a non-Procurement contract and not subject to Procurement rules.

*Program Goals/Predicted Outcomes:

The program provides rapid rehousing to a minimum of 25 households with a minimum of 11 carryovers from prior contract cycle.

*Public Benefit:

Homeless individuals, which is the largest under-served population in Pima County, will be provided with housing.

*Metrics Available to Measure Performance:

The program performance will be tracked in the Homeless Management Information System (HMIS) or a comparable database.

*Retroactive:

Yes. Pima County Board of Supervisors approved ADOH Amendment 6 for a State Housing funds extension on June 21, 2022. The negative impact of this amendment not being approved is Pima County homeless residents would not receive resources for employment and housing.

SUBAWARD - AMENDMENT ONE

1. BACKGROUND AND PURPOSE.

Rapid Re-Housing

1.1. Background.

- 1.1.1. On August 16, 2021, County and Compass Affordable Housing, Inc. ("Subrecipient"), entered into the above-referenced Agreement to provide case management and financial assistance to obtain rapid rehousing for homeless individuals and families and to help program participants overcome barriers to acquiring and maintaining permanent housing.
- 1.1.2. On June 21, 2022, the Pima County Board of Supervisors (the "Board") approved the 2021-2022 Arizona Department of Housing (ADOH) HPF Amendment 6 to extend the term through December 1, 2022 and revise the budget.
- 1.1.3. ADOH Amendment 6 is an extension to spend down the remaining funds on the grant.
- 1.2. Purpose. As a Subrecipient of HPF funds, Subrecipient will conduct all activities under this Agreement accordingly. County finds that it is in the best interests of the residents of Pima County to continue to provide housing and support services for the homeless.

2. TERM, TERM EXTENSIONS, AND AMENDMENTS, SECTION 2. Pursuant to Paragraph 2.1, the termination date is changed:

TO: December 1, 2022
