#### SIXTH AMENDMENT

This Sixth Amendment to Non-exclusive Right-of-Way Use License ("Sixth Amendment") is entered into between Pima County, a political subdivision of the State of Arizona, ("County") and Zayo Group, LLC, a Delaware limited liability company ("Licensee").

#### **RECITALS**

County and Licensee entered into a Nonexclusive Right-of-Way Use License for a Communications System (the "License"), which granted Licensee the right to construct, install, maintain, and operate its communications system known to Licensor as License # LIC-0151.

County and Licensee have executed five Amendments that have extended the term and expanded the area of encroachment in additional areas of Right-of-Way as depicted in the attached Exhibit A.

The License, as amended, is set to expire on August 19, 2022. Licensee wants to extend the term of the License for an additional five-year term, pursuant to Section 2 of the Agreement, and County is agreeable to such an extension of the term.

County wants to revise the License to impose a Renewal Fee, and Licensee is agreeable to the Renewal Fee.

NOW, THEREFORE, the parties agree as follows:

1. The License is renewed for an additional five-year term commencing on August 20, 2022 and ending on August 19, 2027. The Effective Date of this Amendment is upon execution by the Pima County Board of Supervisors. If the commencement date is

before the Effective Date of this amendment, the parties will, for all purposes, deem the amendment to have been in effect as of the commencement date.

2. Licensee will pay County a renewal fee in the amount of One Thousand Nine Hundred Eighty Dollars (\$1,980.00). Licensee will submit payment by check to the Pima County Treasurer and mailed to:

If payment is not received within 30 days of the Effective Date of this Amendment, Licensee will pay interest (simple interest, not compounded) on the past due renewal fee amount at a rate of 10% per annum as allowed by A.R.S. § 44-1201. Interest will be calculated from the date due until paid.

All other terms and provisions of the License and all prior Amendments thereto not specifically changed by this Amendment remain in effect and are binding upon the parties.


