Comments for BOS meeting August 2, 2022

Please include these comments on the official agenda addendum for the August 2, 2022 Pima County BOS meeting. I am a United States citizen and taxpayer, a resident of Pima County, in BOS District 2.

Addendum Item #2 - RESOLUTION NO. 2022 - 44, of the Board of Supervisors, calling for the repeal of A.R.S. Section 3108 and requesting from the Pima County Attorney's Office options to challenge its legality and/or constitutionality. (District 1).

I urge the entire BOS to reject this resolution.

Please remember that the Second Amendment of the Bill of Rights of the United States Constitution gives the people the right to keep and bear arms. The Tenth Amendment states that powers not granted to the United States are reserved to the States or to the people. The state of Arizona has already spoken through ARS 3108. It is a good and clear law, no need for Pima County BOS to meddle.

Addendum Item #4 - Maximus Health Services, Inc., Amendment No. 4, to provide for Contact Tracers, extend contract term to 1/5/23 and amend contractual language, Health Department Ops Fund, contract amount \$5,000,000.00 (MA-PO-20-226) Health.

I urge the entire BOS to reject this contract.

The stated Public Benefit of the contract is the "decreased spread of Covid 19". Various metrics to evaluate performance are referenced, however, there are no reports of the results on these metrics within the Amendment. Where is the proof of the "decreased spread of Covid 19"? The first contract set a limit of \$10M and now the limit is requested to be nearly three times the original limit, at \$28M! As a taxpayer, I believe we are not getting our money's worth.

Covid is no where near the killer it was before everyone had access to vaccines and treatments. Many experts are now saying just about everyone has had or will have Covid, even multiple times. So what is the point in spending so much time and money for continued contact tracing?
