*Purpose:

Consultant services to assist Pima County and City of Tucson, via its US Department of Housing and Urban Development (HUD) Consortium, in providing planning, technical/training assistance and report preparation to complete its required HUD Consolidated Plan, Annual Action Plans, Citizen Participation Plan and updated Analysis of Impediments to Fair Housing. This amendment is to extend the term and add funds.

*Procurement Method:

The Pima County/City of Tucson HUD Consortium sought the services of qualified consultant firms to prepare the HUD plans under solicitation number CDNC-HCD-10-15-18-Al-ConPlan-APP, titled "City of Tucson Pima County Analysis of Impediments of Fair Housing Choice and Consolidated Plan Update." City and County have previously executed an Intergovernmental Agreement to equally share the contractual costs to complete the required HUD Plans. Federal resources to complete these housing and community planning documents utilizing professional consulting firms is HUD eligible.

*Program Goals/Predicted Outcomes:

Goal: Consultant services will provide technical assistance on CARES Act implementation to assist Pima County and the City of Tucson in the prioritization of respective HUD entitlement funding sources.

Predicted outcome: HUD plans will be completed for both the Pima County and the City of Tucson securing HUD entitlement funding and attracting other leveraged resources for the benefit of county residents.

*Public Benefit:

Overall, an estimated \$54 million in HUD entitlement resources will be made available for projects addressing housing, community development, homelessness, and special populations in Pima County and the City of Tucson.

*Metrics Available to Measure Performance:

Upon request, provide technical assistance and training to City and County staff and assist with CARES Act Implementation. Underwrite proposed HOME projects as needed.

*Retroactive:

Yes, due to delays in processing the amendment. If not approved, HUD funding may not be allocated.

CONTRACT AMENDMENT THREE

The parties agree to amend the above-referenced Contract as follows:

1.0 BACKGROUND AND PURPOSE.

1.1. <u>Background</u>. County appropriated \$200,000.00 of FY 2018-2019, FY 2019-2020 Community Development Block Grant ("CDBG") and Community Development Block Grant Coronavirus (CDBG-CV) funds for Kuehl Enterprises, LLC ("Contractor") to provide planning, technical/training assistance, and underwriting report preparation for City and County HUD Community Planning and Development entitlement grant funding for HUD program years 2020-2024.

1.2. Purpose.

- 1.2.1. HUD made "Coronavirus Aid, Relief, and Economic Security Act" or the "CARES Act" resources available to update various CDBG, HOME, Emergency Solutions Grant ("ESG") and Housing Opportunities for Persons with Aids ("HOPWA") plans and policies that were being or had been completed so that they include changes that occurred since the COVID-19 pandemic emergency declarations. To ensure that Contractor can complete the Reports and Plans in Exhibit A, paragraph 1.2, the Board of Supervisors finds it is in the best interests of the residents of Pima County to extend the Contract for one additional year.
- 1.2.2. HUD has recently made HOME American Rescue Plan Program (HOME-ARP) resources available to the consortium to update various HOME plans and policies. To ensure that Contractor can complete the additional Reports and Plans in Exhibit A, paragraph 1.2, the Board of Supervisors finds it is in the best interests of the residents of Pima County to extend the Contract for one additional year to allow Contractor to complete the project.
- **2.0 TERM AND EXTENSIONS.** Pursuant to paragraph 1.2 of fully executed Contract (4/1/19) County is renewing this Agreement for one year. This Contract will terminate on March 31, 2023.

3.0 COMPENSATION AND PAYMENT.

- 3.1. The Maximum Allocated Amount is increased to \$250,000.00.

- 10.2 Assist Consortium with expedited public notice and processes related to amending existing or proposed HUD plans to incorporate HOME ARPA resources.
- 10.3 Help Consortium accurately program CPD CARES Act projects and activities consistent with Con Plan goals, objectives, and performance measurements in IDIS, as amended, modified or waived by HUD.
- 10.4 Meet with County and City to review draft plan and amendments as required by HUD.
- 10.5 After approval and direction from the governing bodies, prepare submittals and work with County and City to upload the respective HOME ARPA projects to HUD.
- 10.6 Prepare HUD required checklists for County and City as needed.

All other provisions of this Agreement, not specifically changed by this amendment, will remain in effect and be binding upon the parties
