Re: Additional Information for the September 6 Board of Supervisors Meeting - Consent Calendar Item No. 28, Clean Air Act Grant Award

Each year, Pima County Department of Environmental Quality (PDEQ) accepts the Environmental Protection Agency (EPA's) application opportunity for a non-competitive grant as detailed in Section 105 of the Clean Air Act, (CAA), "in an amount up to three/fifths of the cost of implementing programs for the prevention and control of air pollution or implementation of national primary and secondary ambient air quality standards. '...implementing' means any activity related to the planning, developing, establishing, carrying-out, improving, or maintaining of such programs."

The timeline of EPA's grant process always dictates that PDEQ (and other agencies) begin encumbering expenses prior to receiving the Final Award. However, the "Please Apply" estimated amount is the budget surrogate, and considered the promise of a forthcoming award. EPA has never withheld this grant, under any previous Administration. PDEQ and EPA are also in continuous contact during the grant period. The choice for marking it "retroactive" on this specific Board of Supervisors Agenda Item Report (BOS AIR) was due to the unusually late arrival of the Final Award (August 10, 2022). Understanding the Board of Supervisors & Clerk of the Board agenda procedures and all the approvals required, with new

approvers in the workflow, there was a small possibility that the Consent Calendar item could come before the Board of Supervisors after the close of the grant on September 30, 2022. The department purposely chose to select "retroactive" on the BOS AIR so this explanation of the procedure and timeline, specific to this grant, could occur.
