This Tuesday, Sept 6th at 9:00 am. - Pima Board Of Supervisors Meeting ...

Every Election Office AND Recorder's Office Election Temp employee needs to go the BOS meeting and during public time - tell what you saw, what happened.

Did the printer run out of paper? For how many hours.

Were there no supplies? For how many hours.

Everything needs to be on the record immediately.

A 'Preliminary Information' is on the agenda. Note: This is not a report and does not claim to be a report. It is a distraction so everyone thinks all is well in Pima. I have attached it.

Here is a glaring omission - only 'one' voting center is named as being 'closed'... what is the definition of 'closed' -- many were unoperational due to lacking supplies, printers down, etc.

Only 'one' had a Commissioner show up to vote..

Larrived at Voting center at 5:30am. There was a lot confusion. This dissipated as problem was identified & corrected.

Paper jam 6:05 - 6:11

Spoiled several voter ballots. A number of test ballots were spoiled.

1st good ballot processed 6:16. 2nd ballot jammed the printer. (Only 1 printer available) 6:20 only one ballot voted. I went outside 75' zone to question voters leaving, ask them "did you get to vote". Voters leaving without casting the ballot

would like to file a complaint. Went to CRCC TO VOTE TURNED AWAY. (Continental Ranch Community Center)

I went to CRCC to find out problem. Mostly personality conflict.

Election personnel offering alternative location to those wishing to cast a ballot. Not a problem to send people there.

Express voting machine(Handcap), Used at 8:10. Prints astrip ballot.

8:21 poll worker instructing voter how to enter data into Express vote machine.

8:33 printer repairman arrived.

8:50 Marana voter using Express vote machine stated Marana Council candidates not on ballot. Confirmed by supervisor.

9:10 I suggested Marana voters be warned.

9:43 started warning Marana voters Effected maybe 10-12 voters total as there were but a few Express Ballots available and for each voter the time consuming process had to be explained. Voting center location #081 was used as location identification in machine. Should have been Precinct # 115. Had that been used Marana Town Council would have been on the ballot. 8:55 repairman requested new printer. 45 minutes.

9:55 new printer activated. Corrected the problem.

Heft at noon. I returned at 3:30 to check il Rep. observer was present. There was, so I went home.
