PIMA COUNTY AMENDMENT #1

to

Public Utility License Agreement (Lic-0192)

THIS AMENDMENT ("Amendment") is entered into between Pima County, a political subdivision of the State of Arizona ("County"), and Arizona Water Company, an Arizona public service corporation ("Licensee"), and shall be effective on the date executed by the Pima County Board of Supervisors.

The parties agree that the Public Utility License Agreement ("License"), dated December 4, 2007 and recorded on December 13, 2007 at sequence 20072400241 in the Office of the Pima County Recorder, is amended to renew the License for an additional 25 years, expiring on December 12, 2047.

All other provisions of the License, not specifically changed by this Amendment, shall remain in effect and be binding upon the parties.
