# EARLY VOTING OPERATIONS After-Action Report August 2022 Primary

Submitted - September 16, 2022

This narrative is provided to the Election Integrity Commission and Board of Supervisors reviewing the Pima County Recorder's Office administration of the 2022 Primary Election Early Voting operations.

### EARLY VOTING OPERATIONS OVERVIEW

For the August 2022 Primary there were 621,789 active voters eligible to participate in the election. 473,175 of those voters were registered as Active Early Voters (AEVL).

For the August 2022 Primary Election, the Recorder's Office entered an active election period starting June 18, 2022, with the mailing of Uniformed and Oversees Citizens Absentee Voting Act (UOCAVA) ballots to overseas voters. The Early Voting period for mailed ballots and inperson voting started on July 6 and ended on July 29. Emergency voting was provided to Pima County Voters on Saturday, July 30 and Monday, August 1.

The Pima County Recorder's Office mailed 363,849 early ballots to voters. 146,587 early ballot packets were returned via mail from July 12 through August 2. 15,910 early ballots were dropped off at early voting locations during the Early Voting period.

On August 3, the Pima County Elections Department delivered 31,087 early ballot packets dropped off at Vote Centers on Election Day. From August 3 through August 8, the Elections Department delivered 4,333 provisional ballots and 35 conditional provisional ballots issued at Vote Centers that required signature verification processing. (See attached Early Ballot Issued Report, and Provisional Ballot Report for additional details regarding reported numbers).

The Ballot Processing Center successfully verified the signatures on **196,624** returned Early Ballot affidavits, which were turned over to the Elections Department for tabulation. (See attached Ballot Turnover Report for additional details.

### BALLOT DROP-OFF SITES / EARLY VOTING LOCATIONS:

The Recorder's Office operated 15 Ballot Drop Off-Sites / Early Voting Sites (EVS) in Pima County from July 6, 2022, through August 1, 2022. Three locations were open from July 6 through July 29. One location was open from July 18 through July 29. And 11 sites were open from July 25 through July 29. Emergency voting was available at 11 locations on July 30 and on August 1 to any eligible Pima County voter.

The sites operated with little to no issues regarding the use of technology. The Recorders' Office deployed 16 ballot-on-demand (BOD) printers and 18 Early Voting laptops or desktop computers.

Information Security at Early Voting Sites Overview:

- EVS internet connectivity from Pima County Libraries is provided via the County network
- Non-county locations used facility provided internet access or secured cellular internet services through Verizon
- Access to the PCRO internal network from ALL Early Voting locations is via secured SSL Cisco VPN connections. The Recorder's Office's on-premises Citrix application environment provides secure PCRO Voter registration system access via user authentication methods and protocols.
- No voter information left the PCRO internal network. Citrix XenApp is an application virtualization service that provides secure on-demand Windows-based applications to devices.

Early Voting locations issued 3,042 on-site early ballots, with the Eastside Replacement location (Fellowship Bible Church) and the Oro Valley Public Library issuing the most. (See attached Early Site Ballots Issued/Spoiled Totals Report for ballot totals issued at each site.)

Historically, the Recorder's eastside office is one of the busiest Early Voting Sites. In 2020, to accommodate increased Early Voting volume, the eastside office was expanded to another vacant office. That additional office is now a Covid clinic for the Health Department and was unavailable for our Early Voting needs for the 2022 election cycle. A replacement site was found less than a mile away that is larger in capacity and easy to access.

In 2021, the Recorder's Office settled a lawsuit with the Pascua Yaqui Tribe and reinstated an Early Voting site for the 2022 Primary.

Previously, the University of Arizona only hosted an Early Voting site for the General Election. To encourage consistency and convenience for the UA staff, students, and surrounding neighborhoods who use the site, the location was opened for the 2022 Primary Election.

All 15 EVSs were supported with three designated site monitors available via phone to answer questions and address any issues raised by EVS workers. The site monitors were critical points of contact to ensure the consistent flow of information between the EVS, the Ballot Processing Center, and the downtown operations hub.

### STAFFING:

During several pre-election update meetings with the Board of Supervisors and the Election Integrity Commission, the Recorder's Office and the Elections Department discussed the need for appropriate staffing levels to meet the demands of administering an election.

Staffing was sufficient in most operational areas but overall lean; some Early Voting sites were nominally staffed with the bare minimum for party balance. Attendance issues at the sites caused last-minute coverage requiring the deployment of permanent staff from our downtown office to EVSs to maintain party balance.

Early Voting Election Staffing Overview:

- 14 Permanent Recording & Voter Registration Staff assigned to various election operations.
- 113 Intermittent Employees assigned to various election operations including:
  - Ballot Processing
  - o Signature Verification
  - Problem Ballot Processing
  - Team Voting
  - Site Couriers
  - Early Voting Sites
  - Phone Coverage
  - o Daily Data Entry

In preparation for the 2022 General Election, the Recorder's Office continues to recruit additional intermittent employees to meet staffing deficits identified during the Primary. Of the 113 Intermittent staff members, approximately 70 had worked one or more election cycles, including the 2020 Election. More than 100 of the intermittent staff members who worked the 2022 Primary will be returning to work the 2022 General Election. Our goal is to increase the number of intermittent staff members from 113 to 160 for the 2022 General Election.

### EARLY VOTING ELECTION WORKER TRAINING:

There are numerous Early Voting operations, and each election task has a specific and detailed training requirement before staff is assigned to a particular job. The Recorder's Office conducts multi-day trainings for each task in advance of the job assignment.

The following training was provided to intermittent staff and permanent staff assigned to various election operations:

- 3 Early Voting Site Worker Trainings
  - 2 Full Day Trainings with hands-on equipment / technology training provided twice (One for the EVSs opening at the start of early voting period & One for the EVSs opening the last week of early voting.)
  - 1 Half Day Training for late hires assigned to EVS
- 2 Signature Verification Certification / Re-Certification Trainings
- 1 Signature Verification Process Training
- 1 Problem Ballot Process Training
- 1 Ballot Processing Training
  - Included Courier & Ballot Chain of Custody Training

In addition to the extended training schedule provided to election workers, the Recorder's Office revised all the training materials and operational manuals to present information in an easily referenced and user-friendly format. Additional preparation time was spent to ensure all EVS workers had up-to-date reference materials available to support daily operations once actively deployed to their assigned EVS.

### **VOTER OUTREACH & ELECTION COMMUNICATION:**

The Pima County Recorder's Office made concerted efforts to inform Pima County Voters of the upcoming Primary Election, including:

- Mailing roughly 430,000 90-Day notices to all registered voters on the Active Early Voting List (AEVL)
- Collaborated with the Elections Department and Communications Department to execute a countywide voter education program
- Financially contributed \$80K to joint countywide voter education campaign
- Provided links to Pima.Gov/Vote2022 and Election Department pages prominently on our website
- Provided information about frequently asked questions and relevant links on outgoing telephone messages
- Made relevant changes to our website on a weekly or daily basis, emphasizing the most frequently requested information in large buttons, prominently on the site
- Created extensive social media posts regarding key deadlines and frequently asked questions

• Sent media releases covering important election dates, frequently asked questions, and recommendations to local news outlets

The Recorder's Office instituted a formal outreach program for under-represented populations. Outreach efforts included trainings, presentations, providing representatives for coalitions, and partnering with non-partisan organizations to educate the community. Special focus was put on voter registration workshops and outreach to the disability community.

The change in the popular eastside location presented a change in voter tradition. In addition to the above methods of communication and outreach, 4 electronic traffic signs were strategically placed at all 4 intersections of the eastside office to redirect voters throughout the Early Voting period. Signs redirecting voters to the new EVS were also placed outside of the eastside office. Additionally, two 4x8 foot banners, visible from the road, were placed at the new EVS location.

The Recorder's Office continued to successfully use the "Track My Ballot" feature on the department's website to help early voters track the status of their ballots from the initial mailing of the ballot to the voter, receiving the voted ballot back from the voter, signature verification process, and ending when the ballot is turned over for tabulation to the Elections Department.

Whenever possible, the Recorder's communication efforts included explanations for specific election processes to help educate our community and establish the office as a single point of truth. This transparency and commitment to demystify complicated processes is critical for maintaining public trust in the electoral process.

### BALLOT CHAIN OF CUSTODY PROCEDURES:

The Pima County Recorder's Office is responsible for verifying affidavit signatures on all early ballots. Those include all ballots issued at Early Voting Sites, received by mail, or dropped off at any Early Voting location or Vote Center. Managing the return of these ballots is part of an extended ballot chain-of-custody process to ensure all voted early ballots are accounted for once in the custody of the Recorder's Office.

### Ballots Returned via United States Mail

The initial mailing of early ballots occurs at the Cherrybell Tucson Post Office, when Runbeck Election Services delivers the packets to Tucson. The bulk of all early ballot packets are mailed from Tucson, and only small secondary batches are mailed from Phoenix thereafter. On July 6, the Cherrybell Post Office received a delivery from Runbeck of 344,989 ballot packets.

The Tucson Post Office handles ballot packets separately from other first-class mail, guaranteeing the ballot packets are correctly sorted to voter addresses for delivery. Upon

return via mail, the Tucson Post Office has a designated team retrieving returned voted ballot packets from general mail sorting. The designated team uses a variety of additional security measures to protect the returned ballots and contacts the Recorder's Office each evening during the early voting period to report the number of ballots ready for pickup.

Pima County Recorder couriers, operating in teams of two from opposing political parties, make daily runs to Cherrybell to retrieve the ballots. Returned ballots are delivered to the Ballot Processing Center where they are documented and stored in the secured ballot room before starting the ballot processing workflow.

From July 12 to August 2, the Courier teams picked up **146,587** mailed ballots from the Cherrybell Post Office.

### Ballots Returned via Early Voting Sites or Issued at an EVS

The 15 Early Voting Sites (EVS) were provided blue plastic early ballot return boxes. Each return box was numbered and assigned to the site with a ballot chain of custody sheet attached to the return box. The boxes were sealed with official numbered sealed zip ties that were tracked on the ballot chain of custody sheet.

Plastic early ballot return boxes were not opened at the EVS and were only opened at the Ballot Processing Center when returned by the courier teams. Once at the center, teams opened the return boxes and documented the opening and ballot count on the chain of custody sheet. All the used seal zip ties and other official election seals are logged and retained as support documentation for the election process.

Each EVS was also provided one metal ballot box with padlocks for site-issued ballots. Metal ballot boxes are always locked on site, except when couriers pick up issued ballots for transport to ballot processing. Site-issued ballots are inventoried, compared to the master ballot issue report, and sealed for transport to the Ballot Processing Center.

Each EVS has blank ballot stock for the ballot-on-demand (BOD) printers sealed in packets of 50 and secured in a locked sealed cabinet when not in use. Also, each EVS had an Express Voting Machine, with blank ballot stock. The Express-Vote Ballot Stock was sealed in packets of 10 and secured in the same locked sealed cabinet, as the BOD ballot stock when not in use. EVS workers must inventory and report ballot stock quantities daily to the site monitors to ensure all blank ballot stock is accounted for.

### PROVISIONAL BALLOT PROCESSING:

During the August 2 Primary, 4,333 provisional ballots and 35 conditional provisional ballots were issued at Vote Centers. Recorder's Office staff successfully verified 4,137 provisional ballots for tabulation. (See attached report for provisional issue reason and conclusion of the provisional ballot detailed report.)

The Recorder's Office Ballot Processing Center experienced some issues with receipt of provisional ballots from the Elections Department post-election day. Some of the operational issues included:

- The Elections Department provided scans of the provisional ballot sheets in some instances that were difficult to read. When original provisional ballots sheets were provided, the carbon copy paper did not have a full transfer of filled-out information, making it difficult to read as well.
- Provisional ballot sheets were incomplete, lacking critical information to identify voters. Missing information included missing signatures, addresses, voter names, etc.

Without complete information on the provisional ballot sheets, staff spent additional time researching voter information before they could process the provisional forms. The Recorder's Office has discussed these issues with the Elections Department. Both departments are committed to working together to remedy these issues prior to the General Election.

Ballot processing staff worked from August 3 through August 11, processing the 31,087 returned early ballots dropped off on election day at Vote Centers, as well as the 4,368 provisional ballots issued. 4,137 provisional ballots were successfully verified and turned over to the Elections Department for tabulation.

The passage of SB 1460, during the last legislative session, will greatly reduce the instances when Vote Center poll workers will need to issue a provisional ballot to voters. SB 1460 allows poll workers to issue a regular ballot to voters who were sent an early mail ballot but did not return the early ballot to the Recorder's Office prior to election day. Had SB 1460 been in effect for the 2022 Primary Election, 3,614 provisional ballots would not have been issued to voters who had received an early ballot by mail but did not vote the early ballot.

### POLITICAL PARTY OBSERVERS:

In keeping with precedent, the Pima County Recorder's Office continued to host political observers at the Ballot Processing Center to watch the early ballot affidavit verification process.

The political observers must be approved by their party chair prior to their visit. Upon arrival, they are given a set of observation guidelines and instructions and security procedures are reviewed. Training materials are offered to each observer. Observers are instructed to only ask questions or make comments to the supervisors on duty.

From July 10 through August 11, political observers from both major political parties sent observers to review the signature verification process at the Ballot Processing Center.

- The Pima County Republican Party sent 26 observers spending about 100 hours total watching the ballot processing center's operations. Republican observers averaged 4 hours per visit.
- The Pima County Democratic Party sent 24 observers and spent about 34 hours total at the facility, with an average of 1.5 hours per visit.

Most political observers followed the guidelines set forth by staff during their visits. However, the following disturbances were reported to the Recorder's Office Administration.

- 1 observer was asked to put away a set of binoculars.
- 1 observer was asked to put away his phone.
- 1 observer refused to wear a mask in the Ballot Processing Center and left of their own accord.
- 1 observer was reminded that "his opinions about fraudulent elections" would not be tolerated.
- 1 observer needed multiple reminders to not speak to the other observers and multiple reminders that they cannot stare at private, voter data during verification.
- 1 observer repeatedly left the secured area, causing a supervisor to allow them back in. She also complained about overheating, and there was concern the observer might have been displaying Covid-like symptoms.
- A common complaint from staff is a violation of personal space from observers, especially female staff members being made to feel uncomfortable by male observers.
- Common complaints from staff are that observers interrupt them "because they're bored" and try to make conversation, which isn't allowed while handling ballots, as high concentration is needed.

The Elections Procedures Manual does not mandate political party observers at Early Voting sites. Some EVSs are open for several weeks during the early voting period and it is difficult to secure large spaces for extended periods of time.

Given that many of the EVSs were physically too small to comfortably accommodate party observers, as well as EVS staff, and the voting public, the Recorder followed the prior practice of not allowing political party observers at sites. In addition to space limitations, the Recorder's Office did not have additional staff available to assist observers during normal operations at the EVS, nor any established guidelines for observers to follow.

### NON-POLITICAL PARTY OBSERVERS:

As public sentiments regarding election integrity rise, our office saw an increase in unaffiliated private citizens demanding to gain access to our facilities to observe. Sometimes these individuals were loud, actively filming or otherwise harassing voters and/or Early Voting Site Workers.

- We had 7 reports of incidents at our Early Voting Sites.
- Observers outside the 75-foot limit were noted, but not considered "unusual"
- Voters often felt intimidated and reported individuals for harassing behavior. The word, "harassing" was used to describe them to Early Voting Site Workers.
- EVS workers reported incidents to the Site Monitors where an individual was within the 75-foot limit without the intention of voting or could be heard from inside the building.
- These individuals were provided an informational sheet regarding observing and often remained outside the 75-foot limit without further incident.
- 2 individuals were asked to leave by the EVS workers after creating a disturbance, both individuals left, one returned and was removed by on-site security after using profanity and disturbing other voters.
- 1 individual returned daily and took photos of staff from outside the 75-foot limit as they walked into the building. The same individual came within the 75-foot limit to take photos of couriers bringing in trays of ballots from the U.S. Post Office into our secured Ballot Processing Facility. He voiced concerns that our vehicles had out of state license plates. It was explained that we were using rental vehicles and had "Official Election Vehicle" magnets on each side prominently displayed.
- One political candidate appearing on the ballot had a particularly strong presence at 3 of our locations and needed multiple reminders to leave voters alone.
- 1 individual appeared at an Early Voting Site Set-up to watch as we unloaded our equipment.

Staff reported feelings of intimidation, harassment, and general uncomfortableness by these individuals. Some sites reported felling unsafe when these individuals sought entrance to EVSs to observer election operations or for those individuals who stayed for extended periods of time outside the 75-foot limit.

### **ELECTION WORKER PHYSICAL SAFETY:**

Staff vocalized growing concerns regarding safety with the increase in angry phone calls and emails related to election integrity. Our administration evaluated the operation safety needs and implemented additional safety measures to address the escalating rhetoric and aggressive behavior directed towards election workers nationwide.

- Many EVSs were in locations already serviced by the County's VetSec Contract Security System
- Several locations shared the same parking lot as police substations
- We discussed an increase in VetSec patrols at our EVS with the director
- Provided de-escalation training to all EVS staff
- Contracted with VetSec to cover 2 locations that didn't have an established security detail: Fellowship Bible Church and our Ballot Processing Facility

- Contacted local law enforcement and provided them with guidance designed for law enforcement designed by the Secretary of State's Office.
- Requested additional patrols from local law enforcement, though at least 1 jurisdiction was unresponsive

Physical safety continues to be a general concern of the staff, especially as the 2022 General Election grows near and tensions continue to grow stronger regarding election administration operations.

### PUBLIC COMMENTS / CONCERNS REGARDING VOTING:

The Recorder's Office received predominately positive feedback from the voting public related to the early voting operations. The relatively few concerns or issues reported by voters were regarding the ballot design, which is not a function of the Recorder's Office, or the envelope design for the early ballot packet, which is a function of the Recorder's Office.

Regarding the ballot packet envelope, multiple voters expressed concern that the rear window showed the color stripe of the ballot style. We contacted our vendor and alerted them to the issue. Runbeck is investigating how to remedy that issue for future primary elections. Runbeck uses the window as a quality control measure to ensure the voter is getting the correct ballot style for their jurisdiction and registration status.

Several voters called wanting additional Early Voting sites farther south in the Green Valley area, farther west in the Avera Valley / Marana area, and farther east in the Vail area. The Recorder's Office will investigate additional early voting locations in those areas for the 2024 election cycle.

We saw many positive comments on social media about the professionalism of our staff, the uniqueness of our stickers, the ease of voting, the improvements on our website and the tracking feature on our website. We also received several pleasant phone calls, and website comments, highlighting the professionalism and dedication of individual staff members and praising their knowledge and customer service.

### CONCLUSION

Early Voting during the August 2, 2022, Primary Election was very successful. The Recorder's Office staff did an admirable job and provided exceptional customer service to the voters of Pima County.

The established election procedures previously adopted by the Recorder's Office were only enhanced this year with continued efforts to document all aspects of election administration to create consistency and uniformity in each specialized election operation. The Recorder's Office continues to solicit feedback from Early Voting site workers to implement additional improvements to create further efficiencies.

We are excited for the 2022 General Election and feel confident that the improvements implemented for the Primary Election will only enhance the overall operations of Early Voting during the General. We know these improvements will ensure our constituents have better access to the electoral process.
