Re: Humanitarian Aid- Item Continued from October 4th Meeting

In late September I requested on behalf of Grants Management & Innovation (GMI) that Agenda Addendum Item 26 for the Tuesday, October 4, 2022 Board of Supervisors meeting be continued to the Tuesday, November 1, 2022 meeting. This continuance of the acceptance of the most recent FEMA Emergency Food and Shelter (EFSP) award of \$10,002,577.54 was necessary, as the award letter received from the funder did not accurately represent that the total award amount included funding from two different sources: \$7,790,548.18 from FEMA EFSP Phase HR22 and \$2,212,029.36 from FEMA EFSP Phase CARES. Since that request, United Way Worldwide, FEMA EFSP's fiscal agent, issued the corrected notice of award.

Please note that the above \$10,002,577.54 has already been wired to the County and is in hand. The correction of the award letter is simply to ensure that the revenue sources are correctly documented in the notice of award. Each of these funding streams has its own guidance and critical differences in cost allowability that must be tracked separately to comport with federal guidance.

Finally, please note that GMI has submitted paperwork to process an additional \$10,002,577.54, again from two separate sources: \$7,790,548.18 from FEMA EFSP HR22 and \$2,212,029.36 from FEMA EFSP Phase CARES. Both tranches combined will bring the County's total award from this cycle to \$20,005,155.08, which is forecast to be completely spent by December 31, 2022.
