During discussion on Addendum Item No. 3, Supervisor Christy had several questions for your department. Direction was given to provide you with the following questions for your response:

1. Do you staff the early and emergency voting sights in the same manner as the Elections Department staffs its vote centers? If so, what are the differences?
2. Is your previously stated policy of not allowing political observers – trained and certified by their own political party – still in effect?
3. The Elections Manual that is generated by the Secretary of State from which your office, as you have stated, was to comply with State Law, was last updated, we believe, in 2019. Is the 2019 Secretary of State's Elections Manual current with all Election Laws that have been enacted since that time?
