I am an Arizona native (living in the Phoenix area) and currently a commercial property owner in Tucson as well as other cities in Arizona and I am writing in strong support of the Tucson Crime Fee Coalition.

I purchased 2 commercial properties in Tucson in 2021 and, so far, I think I might have made a mistake investing in the city. One of my properties on Fort Lowell and Campbell is a daycare/preschool that has been inundated with homeless issues. We have suffered thefts, break-ins, arson, spray painting, human defecation, drug use, and massive amounts of trash due to homeless roaming the neighborhood. Calls to the police are ignored and homeless encampments are not cleaned up despite our efforts to address it with the city. Recently, a homeless man overdosed on the front doorstep of our daycare while the parents were dropping off their children in the morning. The police refused to come out so a call to 911 and an ambulance was necessary to remove him before he died. Keep in mind this is a school with children on the premises. Unacceptable!

Just driving through much of Tucson looks like film set from The Walking Dead. Living in the Phoenix area, which has it's homeless challenges as well, the difference one can see in Tucson is remarkably worse. This cannot continue and the Tucson city government needs to address this now for it's citizens and business owners.

It is my understanding that we have had strong support from Supervisors Bronson and Christy, for which I would like to sincerely thank them.

We need the support of Supervisors Grijalva, Heinze and Scott and for them to insist that elected Mayor Regina Romero and County Attorney Laura Conover work to find solutions to fix this crisis. Furthermore, the staffing issues at TPD need to be fixed immediately.

Please join us in stopping the decay of what was once a beautiful city!
