To the Clerk of the Board of Elections,

I strongly recommend that no certification take place until there is full resolution of a number of issues concerning the 2022 election results. There are several reasons for this recommendation that include:

- The Cochise County Board of Supervisors has currently tabled certification of the mid-term election because they received information that two National Election Equipment Testing Companies, hired by Secretary State, Katie Hobbs, to verify equipment used in an election in which she is taking part, either did not renew or they voluntarily gave up their Federal Accreditation that is required by Arizona law, ARS 16-442b AND the Help America Vote Act HAVA of 2002. They are waiting for the Election Assistance Commission (EAC) to provide evidence that these labs are in compliance, hopefully by November 28th.
- Purposeful widespread voter suppression and confusion caused by "malfunctioning" tabulation machines and printers in Maricopa County, machines and printers that seemed to have worked with no problems in the August primary election.
- Numerous Pima County voters who went through the procedures to be removed from the early ballot list of voters months before the midterms were sent early ballots anyway. How and for what purpose did this happen?

As a concerned citizen of Pima County, I ask that no certification of election results take place until there is full resolution of these issues. We do not have to rush this process. It is better to get it right.

Good morning, Pima Co Supervisors.

PLEASE DO NOT CERTIFY POTENTIALLY TAINTED ELECTION RESULTS. No need to rush the process. Please hold off certification of the canvass results until Cochise County Board of Supervisors receive satisfactory evidence and answers from the US Election Assistance Commission, EAC. Better get it right. Thank you.

Arizonans have presented evidence to you and the Pima Co Election INTEGRITY commission about National Election Equipment Testing Labs, Pro V&V and SLI Compliance, that they were NOT ACCREDITED for a while as required in our laws, ARS 16-442b and the HAVA Act of 2002. You have been duly notified and it's in public records as well as video presentations.

Supervisor Scott has sent to Ms. Ratliff a statement by EAC without a DATE nor a SIGNATURE LINE. Does nobody at the EAC wants to take credit for the letter? EAC states that all was a CLERICAL ERROR. They have also recently CHANGED THEIR BYLAWS! No date of creation of these bylaws was evident. This is highly suspect! Are they trying to fix four years of neglect after the fact? The unsuspecting public cannot be fooled any longer. You and Secretary of State have a duty of care to follow up and produce these for the trusting public.

EAC states, "even though the EAC failed to reissue the certificate, Pro V&V's audit was completed in 2018 and again in early 2021." Where is the evidence? Per their own bylaws, Letters of compliance, certificates, and reports of site visits, financial audits and more are to be posted on their website. Every communication was posted diligently until 2016. What happened?

EAC also claims COVID has prevented compliance. Odd, COVID did not hit the USA until 2020. Accreditation of the National labs that certify our election equipment and software were due prior to that in 2017, and again in 2019.

EAC recently changed their bylaws that the labs can never loose accreditation unless revoked by EAC Commissioners and they INSERTED **52 US Code 20971 (c) (2)**! This reeks of a COVERUP! Original Terms and Conditions were biennial accreditations.

Did they enter a NEW contract with our STATE? Then please produce this as evidence. Note, 25 US States have similar contracts and requirements as Arizona. They may all be in violation and severe breach of contract.

EAC has never voted to revoke accreditation they claim, and a new accreditation certificate was issued on Feb 1, 2021. Didn't they say that COVID prevented travel? COVID hit US in 2020! Not in 2019 when these were due!
