***Introduction/Background:**

Regular Session Agenda Item – Presiding Judge of the Green Valley Justice Court Ray Carroll requests the appointment of the following as Judges Pro Tempore for the period of January 1, 2023 through December 31, 2023: Dr. Damond Holt and Frederick Klein, esq.

***Discussion:**

As an independent justice court removed from the Consolidated Justice Court in Tucson, Green Valley Justice Court has unique needs for coverage in the rare instances the judge is out.

***Conclusion:**

To approve the appointment of the Judges Pro Tempore listed above.

***Recommendation:**

The court recommends the approval of the appointments put forth by the Arizona Superior Court Administrative Order No. 2022-31.

***Fiscal Impact:**

IF APPROVED: It is recommended an incoming Pro Tem judge go through the Judicial College in January. Since Judge Klein is a renewal of his appointment, only Dr. Holt will go through the training. Training is \$750, with per diem and lodging separate.


