Overall, Dr. Holt is extremely well liked by all that work with him and he was very respectful in his deportment, attitude and willingness to lend a helping hand wherever it is needed. He demonstrates considerable initiative and self-motivation in taking charge of each of his undertakings. 
Dear Judge Carroll,
