RE: Response to 12/06/2022 BOS After Action Report Questions

This memo specifically highlights the data requested by Chair Bronson as agenda material Item No. RA 12 for the December 6, 2022, Board of Supervisor Meeting. This document should be considered a supplement to the Pima County Recorder's Office Early Voting Operations After-Action Report.

EARLY VOTING CENTER (EARLY VOTING SITES):

1. Provide by date, how many voters voted at each early voting site, including emergency voting.

9,094 site ballots were issued from 10/12/2022 through 11/07/2022, please see attached daily reports for more detail, (Appendix A).

2. Provide by date, how many vote-by-mail ballots were dropped off at each early voting site, including emergency voting.

From 10/12/2022 through 11/07/2022, <u>41,272</u> early mailed ballots were returned to Early Voting Sites please see the attached spreadsheet for daily detail, (Appendix B).

3. Provide how many early ballots, were dropped off at any of the Recorder's Offices on Election Day.

On 11/08/2022, the Downtown Office and the Country Club Ballot Processing Center received a total of <u>1,235</u> early ballots returned by voters. These ballots were processed on 11/09/2022.

PROVISIONAL BALLOTS AND CONDITIONAL BALLOTS:

1. How many conditional and provisional ballots did the Recorder's Office process?

The Recorder's Office processed a total of <u>**2,561**</u> provisional and conditional ballots.

2. How many of those ballots were accepted for tabulation? How many were rejected and the reasons for the rejection?

<u>**1,857**</u> provisional and conditional ballots were turned over to the Elections Department for tabulation. <u>**704**</u> provisional and conditional ballots were unverified by the Recorder's Office. Please see attached report for reason rejections, (Appendix C).

BALLOTS WAITING TO BE CURED:

1. How many voters failed to respond to your office regarding their signature needing to be cured that could not be forwarded for tabulation.

The Pima County Recorder's Office Special Situations Group – known internally as the Problem Ballot Team – received **2,439 ballots total that required additional follow-up**. The Problem Ballot Team **resolved the issues for 1,469 ballots** and turned those ballots over to the Elections Department for tabulation. **970 ballots were rejected** because the team could not resolve them by the 11/16/2022 cure deadline. See attached report for additional details, (Appendix D).

2. Provide how the vote-by-mail ballots that the Election Department sent to you for signature verification were dropped off at vote centers on Election Day?

The Pima County Recorder's Office does not deploy any ballot boxes to vote centers on Election Day. The Elections Department staff provide vote centers early ballot return boxes and then pickup those boxes on Election Night.

Once those early ballot return boxes are back in the custody of the Elections Department, election staff members empty those boxes and count each returned ballot. The Elections Department then provide those ballots to my office the day after the election with a transfer receipt stating how many early ballots the Elections Department is returning for signature verification. Our office received **44,102 early ballots or "late earlies"** from the Elections Department on 11/09/222.

CAPTURE DATA REQUESTED BT POLITICAL AFFILIATION:

Explain the process for returning ballot boxes to the voting centers for whatever reason prior to the ballot box being inspected at the Elections Department Office.

The Pima County Recorder's Office does not deploy ballot boxes to vote centers, nor does the office pickup ballot boxes from vote centers. Vote Center operations, including ballot box chain of custody, is the responsibility of the Elections Department.

The Pima County Recorder's Office staff does deploy and pickup ballot boxes at our 15 Early Voting Sites open before Election Day. During the 2022 General Election, our courier teams visited each site on a set schedule picking up full ballot boxes and dropping off empty ballot boxes. The chain of custody procedures for this activity are very detailed with considerable documentation accompanying each drop-off and pickup.

The Elections Department does not inspect the Recorder's Office EVS ballot boxes during the early voting period, and we do not inspect the Elections Department's early ballot boxes at vote centers on Election Day.
