PIMA COUNTY WAIVER OF RIGHT TO APPROVE AMENDMENTS TO DECLARATION OF ESTABLISHMENT OF COVENANTS, CONDITIONS, RESERVATIONS AND RESTRICTIONS

(Affecting Instrument Recorded in Docket Book 5754, Page 1031)

Pima County, Arizona, a subdivision of the State of Arizona ("County"), has the right to approve amendments to that certain Amended Declaration of Establishment of Covenants, Conditions, Reservations and Restrictions dated and recorded as of April 13, 1978, and recorded in Docket Book 5754, Page 1031 ("Base Declaration"), as amended by that certain (1) Declaration of Establishment of Supplementary Covenants, Conditions, Reservations and Restrictions of Sin Vacas recorded as of April 14, 1982, in Docket Book 6759, Page 12 ("Supplementary Declaration") of the Official Records of Pima County, Arizona, (2) Settlement Agreement recorded as of June 3, 1986, in Docket Book 7797, Page 1859, Instrument No. 70646 ("Settlement Agreement") of the Official Records of Pima County, Arizona, and (3) Confirmation of Assessment Obligation and Voting Right of the Owner of the Villas at Rancho Sin Vacas to Rancho Sin Vacas Property Owners Association recorded as of June 17, 1998, in Docket Book 10819, Page 810, Instrument No. 19980960305 ("Villas Agreement") of the Official Records of Pima County, Arizona. The Base Declaration, the Supplementary Declaration, the Settlement Agreement and the Villas Agreement may be referred to herein collectively as the "Declaration". The County hereby completely and irrevocably waives its right to approve amendments to the Declaration, and hereby ratifies that it completely and irrevocably waives its right to have approved amendments to the Base Declaration that have been made previously.
