### \*Purpose:

Amendment of Award: Master Agreement No. MA-PO-17-163, Amendment No. 06. This Amendment extends the termination date to 08/31/2023 and increases the not-to-exceed contract amount by \$3,500,000.00 for a cumulative not-to-exceed contract amount of \$19,380,000.00, and appends the contract with the Forced Labor of Ethnic Uyghurs language pursuant to A.R.S. § 35-394. Administering Department: Facilities Management.

### \*Procurement Method:

Pursuant to Pima County Procurement Code 11.24.010, Cooperative procurement authorized, on 2/21/17, the Board of Supervisors approved an award of contract for an initial term of one (1) year and a shared annual award amount of \$3,500,000.00 with four (4) one-year renewal options.

On 11/8/17, the Procurement Director approved Amendment No. 01, which extended the termination date to 02/28/19 and added the shared partial annual award amount of \$1,500,000.00 for a cumulative not-to-exceed contract amount of \$5,000,000.00. Three (3) renewal options remained.

On 11/5/18, the Procurement Director approved Amendment No. 02, which extended the termination date to 02/28/20 and added the shared partial annual award amount of \$2,130,000.00 for a cumulative not-to-exceed contract amount of \$7,130,000.00. Two (2) renewal options remained.

On 12/23/19, the Procurement Director approved Amendment No. 03, which extended the termination date to 02/28/21 and added the shared partial annual award amount of \$1,750,000.00 for a cumulative not-to-exceed contract amount of \$8,880,000.00. One (1) renewal option remained.

On 10/13/20, the Procurement Director approved Amendment No. 04, which extended the termination date to 02/28/22 and added the shared annual award amount of \$3,500,000.00 for a cumulative not-to-exceed contract amount of \$12,380,000.00.

On, 12/07/2021, the Board of Supervisors approved Amendment No. 05, which extended the termination date to 02/28/2023 to align with the cooperative contract and added the shared annual award amount of \$3,500,000.00 for a cumulative not-to-exceed contract amount of \$15,880,000.00

This extension is required for the continuation of goods and services and to allow the State of Arizona to re-solicit a new Cooperative Contract.
